Vaccination Services

COVID-19 Service

The effect of smoking on psychotropic drugs

Did you know that smoking can reduce the effectiveness of some psychotropic drugs? Please see the attached flyer.

It is important to have an awareness of any patients you have on these drugs who sign up for the smoking cessation programme as they may need to discuss their drug dosage with their Consultant before stopping.

If you'd like to learn more about this, you can complete the ASH Scotland learning modules (which are a pre-requisite for the online IMPACT training on the effects of smoking on mental health). There are 2 modules, each taking around 30 minutes with a quiz at the end. The enrolment key is ASHScotland11. (See link below)

Pharmaceutical Care Services Updates Reminder: Pharmacy First PGD Returns

A reminder to return updated trimethoprim and fusidic acid Pharmacy First PGDs which were released in September. Please note the additional training required to be completed before you return the signature pages. The supporting PCA(P) and TURAS modules for completion are all available here.

GP's and the public have now been notified these amendments are live in all pharmacies.

Bridging Contraception PGD Returns

The sexual health service are advertising on their website that eligible patients may obtain POP contraceptive from community pharmacies. Please ensure you have all completed the required training and have returned your authorisation forms for the desogestrel PGD.

Optometry Referral Form

Please be reminded that community pharmacies are required to complete the **Optometry Referral Form** when referring patients to optometrists.

Substance Misuse Team Update

Urgent: Prenoxad Missing Needles

We have received information that some kits of Prenoxad might be missing one or both of their needles. Needles are required to administer this product. There are a significant number of kits from the batches which have been distributed in Grampian however the likelihood of kits missing needles is VERY LOW.

Action:

To check if the needles are in the kits, **DO NOT OPEN KITS.** Instead hold each kit up to a light source. This should allow you to see through the box a bit and look for two dark squares which are present on each of the needles inside the kit. These should be clearly visible. There are photographs and more information in the attached letters which demonstrate this. Advise patients and clients to do the same.

- 2. This can be turned into a positive as it's a great opportunity to check with everyone that their kit is in date and still in one piece.
- Please check all Prenoxad kits that you are currently storing in your service or organisation.
- Please ask all patients or clients of your services to check their kits. If they are unsure, ask them to bring their kits in so we can check them.
- 5. Separate out and store any stock you find and let me know. I have contact with Ethypharm and am happy to let them know.
- 6. If you cannot tell if there are needles in the kit from visual inspection keep it aside and get in touch with me directly for advice (gram.smspharmacists@nhs.scot).

We are keen to ensure patients are not sent away with an open kit. A key part of our local messaging is not to unwrap or open kits unless they are faced with an emergency so that people are confident that their kit is complete, contents have not been tampered and they have everything needed. From the information shared, this should be a very unlikely occurrence but your contact will help me assess this. There is no issue with Nyxoid nasal spray.


in the sector despite the obvious pressures you are having to contend with. The PCS team wish you all the best of luck!
