Strep A Update

In last week's update (09.12.22) we sent a number of documents regarding Strep A infections and antibiotic liquid preparation shortages. Please ensure all staff have reviewed this information:

- 1. PHS information on Strep A infections.
- 2. Community pharmacy guidance for the weekend regarding OOH services (GMED) and antibiotic provision to patients.
- 3. Specialist Pharmacy Service information on using solid oral dosage forms in children.

Updated Information

Alternative liquid antibiotic preparations:

The NHS Grampian Antimicrobial Team (AMT) information relating to alternative antibiotic preparations has now been withdrawn and is superseded by national HIS and SAPG (attached). Please share this with all relevant team members.

Serious Shortage Protocols:

- 3 NHS PCA(P)s detailing Penicillin serious shortage protocols (SSPs) were sent to you today (16.12.22):
 - PCA(P)(2022)35 Phenoxymethylpenicillin 125mg-5ml oral solution sugar free
 - PCA(P)(2022)36 Phenoxymethylpenicillin 250mg-5ml oral solution sugar free
 - PCA(P)(2022)37 Phenoxymethylpenicillin 250mg-5ml oral solution

Changing to an alternative antibiotic preparation:

<u>IP pharmacists:</u> when an antibiotic has been prescribed for Strep A/Scarlet Fever is unavailable AND prescribing is within your scope of practice, an alternative antibiotic preparation can be prescribed in line with HIS/SAPG guidance.

Non-IP pharmacists: when an antibiotic has been prescribed for Strep A/Scarlet Fever is unavailable, timely contact with a prescriber should be made to seek guidance on an appropriate alternative. It is not appropriate to change the medicine prescribed for a patient e.g. phenoxymethylpenicillin to amoxicillin, without discussing with a clinician.

Emergency Care Summary

All community pharmacists, employed or locum, must have access to ECS for patients. This is vitally important over the weekend, evenings and over the festive holidays.

We received a report that one patient went to 4 different pharmacies last Saturday trying to track down a prescription, which could have easily been resolved if the pharmacists had checked ECS.

If you require access to ECS, please contact us and we will provide you with an application form.

If you do have ECS access but your password needs to be reset, please contact gram.cpfacilitators@nhs.scot from your NHS.scot email account.
