Festive Planning in Pharmacies

Dear Colleagues,

As we head into the festive holiday period, we want to provide you with a succinct summary of expectations and support available during the festive period.

Business Continuity Plans

We have outlined a number of times this year the importance of having a robust BCP for your pharmacy / pharmacy group. Having already experienced extreme weather conditions and power outages in certain areas this year, we expect you to include in your BCP what your plan will be if your pharmacist cannot access the pharmacy, there is a power outage or your pharmacy support staff are off sick. Have you chatted through your BCP with your buddy pharmacy? Have you considered back up power generators or making a "power outage" reserve box containing torches / batteries / warm clothes for staff to continue service provision? If a power outage occurs, we do still expect core pharmaceutical care services to be provided where it is safe to do so.

No Pharmacist Present?

Do you and your pharmacy team understand what can legally be allowed if your pharmacist has to leave the premises or cannot get to your pharmacy? Use the vulnerable person checklist available from PCCT to ensure you communicate with patients clearly. GPhC responsible pharmacist regulations are available here.

In addition, if you have SMS patients due for collection or deliveries to be made to vulnerable patients, discuss with your buddy pharmacy transferring these items to their pharmacy for collection / delivery.

Emergency Contact Details

In the event of an emergency, do NHS Grampian have the most up to date details for your pharmacy? Each time an emergency contact leaves your employment, please ensure these numbers are updated and returned to PCCT.

Prof-to-Prof Line

The GMED prof-to-prof line has not been fully restored yet. GMED are accepting prof to prof calls regarding alternative antibiotic prescriptions.

SOP for Closures

Any unplanned closure must be reported as soon as a need to close is identified. It is everyone's responsibility to ensure this document is sent to PCCT (and GMED if a weekend / public holiday) so that signposting of patients to other pharmacies or services can occur. Closure SOP available here.
