King's Coronation

We do not yet have confirmation from NHS Grampian if Monday 8th May will be considered an additional public holiday for independent contractor groups. We will advise as soon as we receive communication.

Pharmacy Closures

We continue to struggle with community pharmacy closures across Grampian. The closures reported to PCCT will now be published on the Community Pharmacy Grampian page here on a monthly basis. This information is publically available.

Moray / North Aberdeenshire Pharmacy Champion Vacancy

To support core, national and local service delivery, NHS Boards receive annual funding to bring on community pharmacy expert "champions", who communicate with and visit pharmacy teams. The pharmacy champion remit is in part defined by the Scottish Government annual direction but they also undertake specific projects as defined by local Boards.

In NHS Grampian, pharmacy champions can either be reimbursed directly or to a specific contractor code, for their time. We meet as a group every month on MS Teams, with quarterly in-person meetings at Westholme, Woodend Hospital, Aberdeen. We ask for a minimum 2 days per month commitment for pharmacy champion activity and reimburse at a rate of £300/day.

We are currently looking to recruit a community pharmacist practitioner champion for the Moray / North Aberdeenshire pharmacies. The ideal candidate will be a service-focused, proactive community pharmacist or technician. We are willing to recruit two champions who are willing to commit to one day per month each.

Reminder: EHC Referrals for <18's

The sexual health service have received a number of enquiries of how best to refer patients under 18

for follow up when they have accessed EHC in pharmacies. The service have kindly provided the following guidance for pharmacy teams:

The best way to make referrals would be by sending the PGD Appendix 5 referral form via email to gram.gshhealthadvisers@nhs.scot or by post to: Health Advisers, Grampian Sexual Health, Health Village, Frederick Street, Aberdeen, AB24 5HY.

We will phone under 16s to offer them an appointment for STI screening / ongoing contraception as appropriate and under 16/17 year olds will receive a text message about how to access our service — either phoning to book an appointment or attending the drop in service. Pharmacists themselves can also advise anyone to check our website for information on how to access our service: the ins & outs - Site (grampiansexualhealthservices.com)
