TSB Emergency Flee Fund


Information on the new TSB Emergency Flee Fund as detailed in the 17th January NHSG Daily Brief: Survivors of domestic abuse encounter many obstacles from leaving an abusive relationship. Economic control over finances can be a major factor. Without control over their money and resources needed to leave and live independently, many women stay with abusers for longer, experiencing more harm as a result. Women who experience economic abuse are five times more likely to experience physical abuse than those who don't. When women experience economic abuse in the context of coercive control. they are at increased risk of being killed. In recognition of this and that the cost-of-living crisis is making it harder to leave abusive relationships, TSB is offering an emergency flee fund for customers. The bank also offers safe spaces in branches and online and the ability to open an account with the normally required documentation.

New Artificial Pancreas for Type 2 Diabetes Manages Blood Sugar Twice as Well as Jabs

Scientists at Cambridge University just completed a successful trial of their artificial pancreas that helps Type 2 diabetes patients better manage their blood sugar levels.

In fact, researchers say the device and app, powered by an algorithm, doubled the duration of time that patients' blood sugar levels were on target. It also reduced by 50% the time they spent with blood sugar that was too high. More info here.
