Changes to prescribing to support the delivery of cost efficiencies/cost avoidance

Summary

NHS Grampian, and the wider NHS as a whole continue to face cost pressures in the delivery of prescribed medication. The NHS Grampian Medicines Management Team, in collaboration with HSCP Lead Pharmacists and HSCP Specialist Pharmacy Technicians are undertaking a project to deliver cost effective prescribing via a dedicated central resource.

Rationale

A number of cost efficiencies have been identified by the Medicines Management Team with the potential to deliver significant savings across NHS Grampian. Ongoing workload and resource challenges can make the undertaking of such efficiencies difficult. By using a centrally dedicated Specialist Pharmacy Technician resource to undertake these tasks we aim to support practices in delivering cost effective prescribing.

Action for Community Pharmacy

The NHS Grampian Medicines Management Team alongside the NHS Grampian Primary Care Prescribing Group and HSCP Lead Pharmacists kindly request that community pharmacy are alert to these changes and where a message has been provided to a patient via their repeat slip that this is brought to their attention, alongside other appropriate counselling, when handing out medication.
