Reminder: Non-Medical Prescribers Barcoded Prescription Forms-Vision

This is a reminder that as part of GP IT Reprovisioning preparation the majority of practices in Grampian have now moved to Vision version DLM830.

This change will enables non-medical prescribers to issue and print a barcoded prescription form. Please note these cannot be electronically claimed for at present until further reconfiguration.

If you receive a prescription from a non-medical prescriber these should be processed routinely as you would any other barcoded GP10.

Nurse Prescribers will continue to use GP10n scripts until supplies cease, these barcoded GP10n forms should be processed same as a barcoded GP10.

Pharmacists and other NMPs will print prescriptions on GP10 script forms.

The 6th digit on the new barcodes will indicate the type of prescriber i.e.:

W- Nurse prescriber

X-Pharmacists

Y- Other NMP

If you do experience any technical issues that may be related to this upgrade please ensure there are reported via facilitators so they can be investigated.
