# **Abiraterone Prescriptions**

We previously asked all pharmacies not to keep stocks of abiraterone / zytiga as no new patients were being initiated in community pharmacies and provision was moving back to secondary care. From Monday 24<sup>th</sup> April, patients will start this phased transition and the completed prescriptions will be sent to one of the 10 local secondary care pharmacy hubs across Grampian for patient collection. # **CoPPr (Community Pharmacy electronic Prescriptions)**

At the recent CPS webinar on Unscheduled Care, there was mention that all prescriptions should now have paper copies, with no requirement to process prescriptions under the COVID19 UCF service tab. Please note that locally, Grampian do continue to use CoPPr via this route and all CoPPrs should be processed by pharmacies in Grampian via this tab until further notice.

#### **NEW: Gluten Free Food Service**

Grampian pharmacies are now available on the GFFS webpage for patients to print order requests and either bring or email to you at the pharmacy. Please see attached handout with screenshot of this process to help you support your patients.

This is a great resource which has a number of product images included, to minimise risk of incorrect product ordered and only lists items on our Grampian GFF Formulary. **Step 1:** Patient fills in postcode of pharmacy. This identifies the pharmacy as being in Grampian and will populate only the Grampian formulary for the patient. They also complete their personal details to calculate the number of units per month they are allowed to order.

**Step 2:** Patient creates their prescription by selecting the items they wish to order that month. Can filter by product type (bread / pasta / crackers / cereals etc.) or by brand. All products are clear on weight and unit calculation. Once item is placed in basket, a countdown of total units remaining is provided.

**Step 3:** Checkout. The screen then confirms the order completion which can then be downloaded as a PDF and printed / taken to pharmacy or emailed to the pharmacy.

### Reminder for Action: SUS Patient Number Audit

All pharmacies are asked to return their current SUS patient numbers audit form (attached) to <a href="mailto:gram.pharmaceuticalcareservices@nhs.scot">gram.pharmaceuticalcareservices@nhs.scot</a> as soon as possible. We still have a number of outstanding responses. Even if your pharmacy has 0 patients, we require this return.
