Medicines Management Update

Shortage of Disulfiram 200mg tablets (Anatabuse®)

Please see the attached document for information on the current shortage of disulfiram 200mg tablets (Anatabuse®). No new patients should be initiated on treatment at this time. As of 14th July 2023, Teva advise that stock may be available again at some point between July - September 2023. Brown & Burk advise they may have stock available mid-August. Target specials manufacturer may be able to supply capsules pack 50 and should be contacted for patients urgently requiring stock. No other specials supplier currently hold stock. Please note requests for specials will require authorisation from the specials team via email.

NES Pharmacy: Designated Prescribing Practitioner Webinar

Emailed Prescriptions

Following extensive feedback and audits of emailed prescription workload, all general practices have been advised that prescriptions should not be routinely scanned and emailed for patient convenience. Where a prescription is clinically urgent to reach the pharmacy on the same day, ideally a relative or patient should collect this from the surgery. If this is not possible, then there are 2 options:

- 1. The barcode of the script is phoned to the community pharmacy <u>by the prescriber</u> and the paper copy left for pharmacy collection or posted to the pharmacy if a collection service is not available.
- 2. The signed script is scanned and emailed to the pharmacy. As above, the paper copy must be left for pharmacy collection or posted to the community pharmacy.

The paper prescription remains the legal document and must be received by the community pharmacy within 72 hours of the request to dispense whether this was made by phone or by email. Pharmacists have

a professional responsibility to ensure that all medications dispensed are from a signed script which has been seen by the pharmacist or phoned through by a prescriber.

Pharmacists cannot accept barcodes emailed or phoned by an admin person or other non-prescriber.

Compression Hosiery Prescriptions

Pharmacies should continue to provide measuring and fitting of hosiery products where required. Community Pharmacy Scotland (CPS) have full guidance on the process to follow from the web link <u>here</u>.

Substance Use Service Update – Buvidal Dispensing

Please be reminded that Buvidal should **not** be dispensed to patients. In Grampian, this has recently resulted in an incident where a patient received and injected their own Buvidal. Please only provide Buvidal to the CPN / key workers collecting on behalf of the patient.

Smoking Cessation Update

Updated Pharmacy Stop Smoking Service Pack – Version 4, Updated June 2023

The training pack has recently been updated and is now available on the Community Pharmacy Grampian website at the link <u>here</u>. Please note that all references to using CO monitoring as a tool within your sessions have been removed at the present time but we will keep you updated with any developments on this and update the training pack accordingly as changes occur.

Also updated on the website is the National Centre for Cessation and Training (NCCT) guidance and the Q&A section which we've updated to include the recurring question around vaping guidance. The Q&A's have also been included within the updated training pack.

Healthpoint Services

Healthpoint is more than just a smoking cessation service in the community. They also offer free advice on:

- Practical ways to improve your health.
- Your health concerns.
- Support groups and organisations.
- How to access NHS services.
- Long term conditions e.g. asthma, diabetes.
