Medicines Management Shortages Updates

Please find attached information regarding disopyramide 100mg immediate release capsules and 250mg Modified Release tablets shortage and atomoxetine shortage.

Rifinah Tablets

Due to recent supply issues with Rifinah 300/150mg tablets, the manufacturer Sanofi has placed this product onto a quota system. It is currently stocked by AAH and Phoenix wholesalers. Each pharmacy has a separate quota and if no packs have been ordered for a while this will be set at zero. The wholesaler system should indicate if the quota has been exceeded. If the quota has been exceeded then Rifinah tablets can still be ordered but a copy of the prescription (with all patient details redacted) must be sent to DTP-UK@sanofi.com together with your wholesaler account number. Stock should be delivered within 24 - 48 hours of this email being received.

Smoking Cessation Update

Using Text Messaging within Smoking Cessation Services

Following a text trial pilot some months ago using a small amount of pharmacies, it's been shown that text messaging may be a valuable tool in some instances for keeping communication channels open within the smoking cessation programme.

Face to face consultations are always desirable but, as not everyone is able to come into the pharmacy on a weekly basis, the goal is to keep communication channels open for the full 12 weeks by any means that works for your patient. If you think texting may be a valuable tool in retaining patients, then please do use that method as a further tool of communication.

Public Health Update Period Poverty

The Period Products (Free Provision) (Scotland) Act 2021 ("the Act") was passed by the Scottish Parliament on 24 November 2020 and received Royal Assent on 12 January 2021. Community Initiatives North East (CFINE) CFINE - Period Poverty - NACWG (generationequal.scot) can now provide free sanitary products to all pharmacies within Aberdeen City. If you'd like to stock free products, please contact CFINE. They will deliver the products straight to the pharmacy and you can subsequently order on-demand or set up an automatic repeat delivery system.

We are also currently looking at options for pharmacies in Aberdeenshire and Moray and will keep you updated.
