Vaping Update

Did anybody watch the BBC Panorama episode "Teenage Vaping, What's The Harm"? It was very informative and worth a watch on BBC iPlayer. The general consensus remains that vaping is MUCH better than tobacco smoking. The Department of Health, backed by medical doctors at the Royal College of Physicians, regularly tell smokers that they'd be far better off if they vaped, and that vaping is **95% less harmful** than smoking. Remember to remind patients that vaping is a better alternative to tobacco smoking and if they can vape instead of smoking, they are classed as a smoking quit.

Young people, who have never smoked, taking up vaping remains a big issue and there are new Governments directives in the pipeline to combat this problem.

New Recycling Scheme Trades Broken Plastic Toys for Books

Old plastic toys can be swapped for books through a new recycling scheme, Recycle to Read. Running from 4th September until 4th December, the green initiative organised by toy company Hasbro and environmental education company, Wastebuster, encourages families to recycle their broken, hard plastic toys via recycling bins placed in Tesco stores. Each child will be rewarded with a book when they make a donation. The first of its kind, broken toys will be cleaned and turned into plastic pellets, before being used to create new items.



Katy Newnham, founder of Wastebuster said: "Recycle to Read supports families in learning about the environmental benefits of toy rehoming and recycling, while rewarding them with books for taking part.
