Update: Buccal Midazolam Preparations for Prescribing in Paediatrics

Recently some new strengths and preparations (2.5mg, 5mg & 7.5mg pre-filled syringes) of buccal midazolam, as the Epistatus® brand, have become available for prescribing in children as rescue treatment for status epilepticus. Please find the attached document which highlights the preparations recommended locally.

Patient Safety: Prescribing of 'Higher' Strength Buprenorphine Transdermal Patches

When prescribing 'higher' strength buprenorphine patches (i.e. 35, 52.5 or 70 micrograms/hour) to ensure that patients receive an appropriate product with directions detailing the correct frequency of application, it is recommended that:

- Prescribing is done by brand name Bupeaze®, and
- Prescribed directions should be clear: Bupeaze® should be replaced after 96 hours (4 days) at the latest. For convenience of use, the transdermal patch can be changed twice a week at regular intervals, e.g. always on Monday morning and Thursday evening.

This information relates to higher strength buprenorphine patches only, 'lower' strength patches (i.e. 5, 10, 15 and 20 micrograms) should be prescribed generically. Please find the attached guidance for more information.

Syringe Pump Referral Line

In **Aberdeen City**, if any syringe pump, nursing notes or other equipment is accidentally returned to the community pharmacy along with unused medication, please contact the City Community Referral Line on 01224 559140 or <u>gram.citycomrefline@nhs.scot</u>, who will be able to advise which community nursing team was involved (based on the patient's home address) and ask them to organise collection.

For Aberdeenshire & Moray patients, please make contact via the patient's medical practice.

Elastic Hosiery Prescriptions

All pharmacy teams are expected to measure and fit standard compression hosiery for patients where clearly prescribed but wrong product issued e.g. XXL size for a very slender leg. Where there is a requirement to measure and fit stockings, an endorsement will enable additional payment of £25 to be awarded to the pharmacy. There is no additional fee awarded to pharmacies for measuring "made to measure" stockings. For M2M, there is a requirement for the patient to be measured first thing in the morning. CPS have provided a guiding statement regarding this:

If the patient cannot attend the pharmacy in person, a bespoke solution will need to be found by the various members of the CP, GP, Care Team members and the patient. Very much the team members working together to get a solution for the patient.

Gluten Free Food Service

GP Practice Protected Learning Time (PLT)

For awareness, the Out of Hours Primary Care Service (GMED) will be supporting Protected Learning Time (PLT) for all GP Practices during November 2023:

- Wednesday 15th November 2023: GP Practices within Moray will close from 1:30pm to 6pm.
- Tuesday 21st November 2023: GP Practices within Aberdeenshire will close from 1:30pm to 6pm.
- Wednesday 29th November 2023: GP Practices within Aberdeen City will close from 1:30pm to 6pm.

All GP Practices within the above-mentioned geographical areas will close under each date and time, and will participate in PLT. During these periods of PLT, GMED will provide urgent care and advice to all Grampian patient while their respective practices are closed.
