Guanfacine Shortage

Guanfacine (Intuniv®) modified release tablets (2mg & 3mg) have gone into short supply with a return date of early May 2024. Many patients have recently been re-titrated, or are in the process of re-titrating following the previous guanfacine shortage. The shortage information (attached) has been disseminated to GP practice pharmacy teams, via HSCP Lead pharmacists, for action in practices. Due to the short time frame of supply issues, it is anticipated that not all patients will be impacted on this occasion.

Community pharmacy colleagues should be aware of the actions within the shortage document and ensure timely contact with prescriber when a shortfall in medication is identified.

Isosorbide Mononitrate (Monomil XL): MSAN and SSP

A supply issue with isosorbide mononitrate (Monomil® XL) 60mg modified release tablet has been identified. In order to manage stock supplies fairly and effectively, please find the attached UK-wide Serious Shortage Protocol (SSP) in addition to the Medicine Supply Alert Notice (MSAN), which allows community pharmacists to substitute a prescription of the noted product with the same quantity but different brand of isosorbide mononitrate 60mg modified release tablet.

Smoking Cessation

Joint Position Statement on Tobacco Smoking and Vaping

Last week, the UK, Scottish and Welsh Governments and Northern Ireland Executive announced new measures to protect children and young people from the harm caused by smoking and vaping. This marks an important step towards creating a smoke free generation and helping tackle youth vaping.

Public Health Scotland has published on behalf of the Scottish public health system a position statement on stopping tobacco smoking and youth vaping, reflecting our joined commitment to addressing their detrimental effects on public health.

Within the statement, the importance of collective action to address this public health challenge is underlined within the six areas of action. We hope that this output, the first from the Scottish Public Health System, will help to foster ongoing collaboration and dialogue amongst stakeholders at all levels, so that we can reduce the burden that tobacco smoking and youth vaping place on our communities.
