1. Provision of a monitored dose system should only be supplied when it is the most appropriate choice for the patient. Pharmacists are expected to formally assess requests for monitored dose systems and advice for this is available on our website.

- 2. Patents requiring monitored dose systems tend to be on chronic medication. Registration of the patient for CMS and completion of a PCR (regardless of whether the patient is registered for CMS or not) is the recommended way of recording both that a formal assessment has been carried out and the reasons why that assessment has resulted in supply of a monitored dose system.
- 3. We reserve the right to call for records of patient's assessments in order to verify claims.
- 4. A revised claim form which reflects these updates is attached and should be used from 1st August 2012. Copies will also be posted on the Compliance Assessment section of the above website.
