REMINDER	Incomplete Stage 1 assessments
	Under arrangements for Medicines, Care and Review (MCR), all patients are entitled to receive pharmaceutical care and as such, the Pharmacy Care Record (PCR) has now been changed to reflect the new requirements for the service. All patients registered for the service must have a completed patient profile and a completed Stage 1 assessment within 16 weeks from registration. It is the completion of the stage 1 assessment that triggers the current payment associated with the registration.
	In addition, details for the service contained within NHS Circular: PCA (P)(2021) 3 Additional Pharmaceutical Services .Medicines: Care And Review Service – Directions And Service Specification, there is a new requirement for an annual assessment to take place. The PCR update now includes a new reporting tool to identify when these new annual assessments are due.
	As part of the wider support for the service, I monitor activity with the stage 1 assessments and the most recent report (based in registrations and assessments on 1 <sup>st</sup> August) have shown that some pharmacy teams have larger numbers where the stage 1 assessment appears to have not been completed. This means that you will not have been paid for the registration for this patient.
	To help community pharmacy teams, I recently sent each a copy of the registrations and number of missing stage 1 assessments as of 1 <sup>st</sup> August for you to review and action as

appropriately. It may be that the reviews have taken place but the "complete" button has not been triggered. It may also be possible to conduct this review safely in a face to face environment with the patient, on the telephone or via NHS Near Me or other VC methods that you may have access to use for those assessments that are still outstanding.
I hope that you find the report helpful but please feel free to contact either myself by email or phone, or your local Community Pharmacy Champion for advice.

IMPORTANT INFORMATION	Reinstatement of Pharmacy Visit Programme – 2022
	You may remember several years ago, members of the Community Pharmacy Team (CPD Team) undertook a programme of pastoral visits to the community pharmacy network in NHS GGC.
	This programme was put on hold when Richard Duke, Contracts Manager left the organisation in 2017.
	We are delighted that the CPD Team are now in a position to reinstate this programme. Visits will recommence from January 2022 (dependent on any Government restrictions in place at the time).
	As before the initiative will provide community pharmacists with an opportunity to secure protected time with members of the CPD Team to raise and discuss all/any issues which you feel relevant. Anything that can't be answered on the day will be investigated further and a response provided. The topics which will be covered during the visit will include: validation of the pharmacy's information held on Pharmaceutical List; communication networks; premises issues; PGD information and pharmacist prescribing. This list is not exhaustive and will evolve over time.
	With 289 community pharmacies across the Board to visit, this programme will stretch across the entire calendar year. The aim of this communication is to let you know that the programme is restarting with the support of CP GGC, and that it will be co-ordinated by one of our Contracts Administrators. The pharmacy will be contacted prior to the visit to ensure the principal pharmacist will be available on a specific date and to arrange a suitable time. These arrangements will be formally confirmed by letter prior to the visit.
	In the meantime we wish to stress that these visits do not replace any normal contact with us and we hope you will view this as a positive development. I must stress that this is a pastoral visit, primarily to ensure that the information held on the Board's Pharmaceutical List database is up to date.
