

|                          | The aim of the guideline is to standardise prescribing practice of Proton Pump Inhibitors (PPIs) whilst ensuring patients are given appropriate and effective treatments. It covers the use of PPIs in neonates and paediatric patients, across primary and secondary care, within NHS GGC. It is intended for use by all health professionals involved in the care of these patients, including community pharmacies who may be presented with prescriptions for a PPI in this patient group. Choice of preparation is dependent on various factors, for example, patients' age and weight, dose required, and whether the patient has an enteral feeding tube. Examples of preparations included in the guideline are unlicensed omeprazole 20mg/5ml oral solution (Aclomep <sup>®</sup> ), licensed omeprazole dispersible tablets (Losec MUPS <sup>®</sup> ) and licensed lansoprazole orodispersible tablets (Zoton FasTabs <sup>®</sup> ). |
|                          | Aclomep <sup>®</sup> 20mg/5ml oral solution should be only be used first-line for patients with fine bore feeding tubes, or in babies weighing less than 1.7kg, where Losec MUPS® cannot be used. Please be aware some suppliers may request justification of need for Aclomep® 20mg/5ml oral solution at the point of ordering, for example, a letter from a prescriber.  |
|                          | Losec MUPS <sup>®</sup> can be halved and the dose rounded to nearest 5mg, and dispersed in a small amount of water, and may be considered from birth if the baby weighs 1.7kg or more.  |



| REMINDER | NHS GGC Clinical Guideline; Proton Pump Inhibitor Guideline for Neonates and Paediatrics - July 2022   |

|          | The clinical guideline can be accessed <u>here</u> .   |
|          | The aim of the guideline is to standardise prescribing practice of Proton Pump Inhibitors (PPIs) whilst ensuring patients are given appropriate and effective treatments. It covers the use of PPIs in neonates and paediatric patients, across primary and secondary care, within NHS GGC. It is intended for use by all health professionals involved in the care of these patients, including community pharmacies who may be presented with prescriptions for a PPI in this patient group. Choice of preparation is dependent on various factors, for example, patients' age and weight, dose required, and whether the patient has an enteral feeding tube. Examples of preparations included in the guideline are unlicensed omeprazole 20mg/5ml oral solution (Aclomep <sup>®</sup> ), licensed omeprazole dispersible tablets (Losec MUPS <sup>®</sup> ) and licensed lansoprazole orodispersible tablets (Zoton FasTabs <sup>®</sup> ). |
|          | Aclomep <sup>®</sup> 20mg/5ml oral solution should be only be used first-line for patients with fine bore feeding tubes, or in babies weighing less than 1.7kg, where Losec MUPS® cannot be used. Please be aware some suppliers may request justification of need for Aclomep® 20mg/5ml oral solution at the point of ordering, for example, a letter from a prescriber.  |
|          | Losec MUPS <sup>®</sup> can be halved and the dose rounded to nearest 5mg, and dispersed in a small amount of water, and may be considered from birth if the baby weighs 1.7kg or more.  |
|          | Patients should be reviewed regularly to ensure ongoing need for treatment. When patients are weaned onto solids (at 6 months of age) then consideration could be made to switching to omeprazole capsules which can be opened and dispersed in water or soft foods, as long as the dose can be safely rounded to 10mg (i.e. patients weighing more than 3.3kg). Clinical<br>effectiveness should be monitored, and additional or alternative treatments may need to<br>be considered.  |
|          | 3. For advice on alternatives for new patients being considered for a GLP-1 receptor agonist, refer to the Department of Health and Social Care Medicines Supply Notifications (MSNs) for dulaglutide and semaglutide and further information below.  |

|          | Semaglutide is also available as a once daily tablet (Rybelsus®). Other parenteral GLP 1 receptor agonists that remain available include exenatide and liraglutide. |          | Liraglutide 1.2mg daily would be the first line alternative if semaglutide 0.5 mg weekly becomes unavailable. If previously stopped liraglutide due to intolerance or poor response, consider weekly exenatide (Bydureon) second line.<br>Liraglutide optimises cardiac and renal protection which is why it is recommended over weekly exenatide or oral semaglutide. (LEADER Clinical Trial evidence) |
|          | Please also note the effect of switching between oral and SC semaglutide cannot easily<br>be predicted because of the high pharmacokinetic variability of oral semaglutide. |          | The aim of the guideline is to standardise prescribing practice of Proton Pump Inhibitors (PPIs) whilst ensuring patients are given appropriate and effective treatments. It covers the use of PPIs in neonates and paediatric patients, across primary and secondary care, within NHS GGC. It is intended for use by all health professionals involved in the care of these patients, including community pharmacies who may be presented with prescriptions for a PPI in this patient group. Choice of preparation is dependent on various factors, for example, patients' age and weight, dose required, and whether the patient has an enteral feeding tube. Examples of preparations included in the guideline are unlicensed omeprazole 20mg/5ml oral solution (Aclomep®), licensed omeprazole dispersible tablets (Losec MUPS®) and licensed lansoprazole orodispersible tablets (Zoton FasTabs®). |
|          | Aclomep <sup>®</sup> 20mg/5ml oral solution should be only be used first-line for patients with fine bore feeding tubes, or in babies weighing less than 1.7kg, where Losec MUPS® cannot be used. Please be aware some suppliers may request justification of need for Aclomep® 20mg/5ml oral solution at the point of ordering, for example, a letter from a prescriber.   |
|          | Losec MUPS <sup>®</sup> can be halved and the dose rounded to nearest 5mg, and dispersed in a small amount of water, and may be considered from birth if the baby weighs 1.7kg or more.   |
|          | Patients should be reviewed regularly to ensure ongoing need for treatment. When patients are weaned onto solids (at 6 months of age) then consideration could be made to switching to omeprazole capsules which can be opened and dispersed in water or soft foods, as long as the dose can be safely rounded to 10mg (i.e. patients weighing more than 3.3kg). A further review should be undertaken when the patient is around one year of age, as it is expected regurgitation and gastro-oesophageal disease symptoms may have resolved for the majority of patients by this age.  |

|          | The aim of the guideline is to standardise prescribing practice of Proton Pump Inhibitors (PPIs) whilst ensuring patients are given appropriate and effective treatments. It covers the use of PPIs in neonates and paediatric patients, across primary and secondary care, within NHS GGC. It is intended for use by all health professionals involved in the care of these patients, including community pharmacies who may be presented with prescriptions for a PPI in this patient group. Choice of preparation is dependent on various factors, for example, patients' age and weight, dose required, and whether the patient has an enteral feeding tube. Examples of preparations included in the guideline are unlicensed omeprazole 20mg/5ml oral solution (Aclomep <sup>®</sup> ), licensed omeprazole dispersible tablets (Losec MUPS <sup>®</sup> ) and licensed lansoprazole orodispersible tablets (Zoton FasTabs <sup>®</sup> ). |
|          | Aclomep <sup>®</sup> 20mg/5ml oral solution should be only be used first-line for patients with fine bore feeding tubes, or in babies weighing less than 1.7kg, where Losec MUPS® cannot be used. Please be aware some suppliers may request justification of need for Aclomep® 20mg/5ml oral solution at the point of ordering, for example, a letter from a prescriber.  |
|          | Losec MUPS <sup>®</sup> can be halved and the dose rounded to nearest 5mg, and dispersed in a small amount of water, and may be considered from birth if the baby weighs 1.7kg or more.  |
|          | Patients should be reviewed regularly to ensure ongoing need for treatment. When patients are weaned onto solids (at 6 months of age) then consideration could be made to switching to omeprazole capsules which can be opened and dispersed in water or soft foods, as long as the dose can be safely rounded to 10mg (i.e. patients weighing more than 3.3kg). A further review should be undertaken when the patient is around one year of age, as it is expected regurgitation and gastro-oesophageal disease symptoms may have resolved for the majority of patients by this age.   |



| There is sometimes, although not always, advice issued from the MHRA or Scottish Government or both. These are called MSN (MHRA) or MSAN's (Scottish Government) these provide information relating to the shortage and the estimated recovery date if known. There may also be a Serious Shortage Protocol (SSP) issued with specific advice for Community Pharmacy. These communications are shared locally via the Community Pharmacy Development Team newsletter.  |
| Where items are in short supply, out of stock or only available above tariff cost, this can<br>be reported by the contractor via the Community Pharmacy Scotland shortage reporter<br>(CPS Members Area   shortages). This report, along with other information, is used to<br>influence any potential tariff concessions at a national level. The Health Board cannot<br>influence these discussions and would encourage all CPs to report issues to CPS to<br>ensure as much information is available as possible. |
| When a shortage is in effect, we would encourage pharmacies to try all wholesalers available to them; check for all strengths, pack sizes and presentations including branded prior to asking the prescriber for an alternative.   |
| The Health Board endeavour to take a proactive approach with shortages, or short supply medication and community pharmacy teams can report potential shortages to us via their clinical mailbox or NHS.scot account to the prescribing team inbox, prescribing@ggc.scot.nhs.uk we can then assess potential for disruption and may follow up with suppliers. We cannot do this for all shortages, however.   |
