MEET THE TEAM - Laura Sproat


what is your current role? Administration & Clerical Officer

Logan Pharmacy

Emma (pharmacist) received a distressed phone call late one afternoon from the wife of a patient stating that carers had administered the incorrect medication to her husband. Emma took swift action and escalated this to the GP Practice and the CAP Techs. As a result of this swift intervention the patient had a home visit, appropriate medications withheld for a period of time and allowed for learnings and steps to be put in place with the homecare provider to prevent such an event reoccurring. The patient was fortunately unharmed and both he and his wife were very grateful for Emma's help.
