MEET THE TEAM - Roisin Kavanagh



What is your current role? Director of Pharmacy which means I am responsible for the pharmacy service for NHS Ayrshire & Arran, what we would typically describe as the managed service which includes pharmacy services delivered in hospitals, GP practices, Intermediate Care and Mental Health. I am also responsible for medicines governance and I am the Controlled Drug Accountable Officer for NHS Ayrshire & Arran which means I provide assurance to the Board that controlled drugs are being managed appropriately throughout the Board area.

How long have you worked with NHS ASA? Almost 9 years, unbelievably! What roles have you previously held? I was previously Lead Pharmacist University Hospital Crosshouse & Operational Services; prior to that I worked in the South of England for 13 years in various roles including:

Clinical Services Manager; Programme Director for the PG Diploma in General Pharmacy Practice, University College London; Practice Educator Pharmacist; Admissions Pharmacist and in my early years I worked in various roles in hospital pharmacy including Medicines Information at Yorkhill Hospital and Rotational roles in NHS Lanarkshire.

what's the best bit of your job? That's a tough question as there are lots of elements of my job that I love. If I could have two best bits they would be: having a positive impact on the care of patients and the population through our service and being able to support staff to develop to reach their potential (which also has a positive impact on patient care).

I'm an avid reader of fiction which is a good distraction. Stat of the week - ECS access from Community Pharmacies

In edition 1 of 'Weekly Script' we shared with you the growth of ECS access. I'm delighted to share that this continues and we now have almost 50% of our pharmacies accessing ECS on a regular basis to improve patient care. In December ECS was accessed by 45 individual pharmacists a total of 429 times! That's 429 patients benefitting from better, safer care through appropriate use of systems and resources available!
