### GOOD NEWS STORY - LOGAN PHARMACY

Karen Smith, CAP tech (above) shared this good news story about Logan Pharmacy.....Well done and thank you to the team @ Logan!

On 07/06/23 at 1pm I received a distressed call from social work saying that a patient in East Ayrshire with complex health conditions and L3 medication had had to go and stay with an elderly family member in South Ayrshire because of an emergency situation. They could not get any carer company to manage the L3 and the elderly family member could not dispense from the original packs as too many and too confusing. Logan pharmacy (not patient's usual pharmacy) agreed that if GPCP provided dispense weekly prescriptions they would turn around a blister pack as soon as possible. I received a call from Logan pharmacy on 08/06/23 at 10:30 am to say that the blister was ready for collection, which was then delivered to South Ayrshire. Emma and her team showed sympathy and compassion for the patient's situation and turned it all round so quickly in conjunction with the pharmacotherapy team. Social work staff were very thankful for the help and support.

# Key Messages

## Epistatus 2.5mg Prefilled Syringe

Veriton Pharma are aware of a shortage of Epistatus Pre-filled Syringes which is anticipated to be resolved in the next 2 weeks. In order to mitigate the impact this may have on Patients, an extension to the shelf life of existing products has been reviewed. On assessment of stability data, the expiry date for the following products and batches is able to be extended by 2 months without adversely affecting the quality, safety or efficacy of the product. This statement is valid so long as the product in question meets the following parameters:

- It has been stored in the conditions stated on the outer pack, namely: "Store below 25°C. Do not refrigerate."
- The carer follows the instructions within the PIL (printed inside the outer carton) which states "The product must be discarded if the solution is not clear or if the solution contains particles or crystals."

## Oxcarbazepine Liquid 60mg/ml Shortage

We are aware of an ongoing shortage of Oxcarbazepine liquid. Recently a number of patients have been directed to our hospital dispensaries to obtain supplies of this medication. The hospital are also experiencing this shortage and no do not have supplies available. We would like to remind all community pharmacy teams to ensure the shortage protocol is followed and that patients are directed back to primary care colleagues if supplies cannot be obtained through the community pharmacy network.
