GOOD NEWS STORY - FENWICK PHARMACY

This week we received an email from a member of the NHS Care At Home team to highlight excellent patient care at Fenwick Pharmacy. The team had supported a patient with sight impairment who was prescribed a number of eye drops. This patient has no sight in his left eye and this made it extremely difficult for him to know what drops to put into each

The member of the Care At Home team and the pharmacy worked together to devise a colour coded system where the pharmacy put coloured tape on his drops "red for right, blue for left, and red/blue for both" to help the patient identify his eye drops more easily. To quote the Care At Home team member "Ash and the staff at Fenwick are always looking for ways to support their patients, an amazing bunch"

This is a great example of collaborative working between sectors and offering a bespoke service to deliver great patient care. Well done to everyone involved!

Key Messages

Epistatus

Following the message last week regarding Midazolam we have an update to share regarding obtaining stock of the licenced Epistatus pre-filled syringes.

These can be ordered from Alliance Healthcare via the following PIP codes and these are all currently in stock.

Product Name	PIP code
Epistatus 2.5 mg	540-0759
Epistatus 5 mg	540-0767
Epistatus 7.5 mg	540-0775
Epistatus 10 mg	540-0783

We are aware that some PMR systems have not yet been updated with these products (including Columbus which will be updated on 23rd July) but these products ARE available via the Alliance portal or telephone ordering.

Again, further to last week's message (below) watching the following video may help pharmacy teams understand the reasons why patients / carers can NOT give part doses of Epistatus.

(Repeat message) Midazolam 10mg/ml oromucosal liquid (Epistatus)

The above liquid is now licensed and available (via specials suppliers) as pre-filled syringes which contain 2.5mg in 0.25ml, 5mg in 0.5ml, 7.5mg in 0.75ml and 10mg/ml. A full prefilled syringe, given as a single dose is the preferred choice however in certain circumstances, the 5ml bottle (with 4 syringes) may be prescribed.

Please be aware that there are 4 DIFFERENT sizes / strengths available!

All strengths are now licensed however at present only the 10mg/1ml prefilled syringe appears in the BNF-C. The prefilled syringes are not graduated, so can only be used to administer the full volume they contain.

The pediatric epilepsy service are having reports of parents being given prefilled syringes from which they have to decant the prescribed dose. This is not appropriate. If a prefilled syringe of the correct dose is not available then the 5ml bottle should be prescribed.
