We are working on a final communication which will hopefully include detail of PIP codes for vaccines and this will be issued ASAP.

# Tradebe – Collection of Unwanted Patient Medicines

Our waste collector Tradebe have now moved to a computerised model of working whereby they will no longer provide you with any paperwork when they collect or leave pharmacy waste bins. This new way of working has been introduced with immediate effect. Tradebe provide us with details each month of how many bins they have collected from your pharmacy which we keep details of as the Board is deemed to be the producer of patient returned medicines.

Please remember that these bins are provided for patient returns only and it is really helpful if the outer packaging can be removed to allow more capacity in the bin. Also as I am sure you are aware out of date stock should not be placed in this bin.
