A few months ago a patient attended this pharmacy looking for a cough bottle. The patient spoke to Janine the pharmacist, and on further inspection of the patient's PMR, Janine noticed that the patient had recently been prescribed antibotics three times to help with a chest infection. The patient explained that she just couldn't shift her cough and hoped that a cough bottle would help.

Concerned, Janine strongly advised the patient to see her GP again face to face and explain that she, the pharmacist, had requested this due to this continuous cough and the length of time this had been present.

Fast forward three months and the patient came back in to the pharmacy to thank Janine for her level of compassion and care. The patient had unfortuantely been diagnosed with lung cancer but because of Janine's insistance that she saw her GP, this diagnosis was picked up quickly and she was now recovering from surgery and treatment.

National Naloxone Service.... 4 Weeks Until Service is Live!!!

The naloxone emergency supply service will be added to the community pharmacy Public Health Service from 30 October 2023. This will replace the existing NHS local enhanced service and extend the service to all pharmacies in Scotland.

Details are available from Community Pharmacy Scotland or from the NHS Circular PCA(P)(2023) 34.

Community pharmacy teams should now complete the e-learning module for naloxone emergency supply by visiting <u>NES TURAS Learn</u> and searching for *'Community Pharmacy Emergency Naloxone Holding Service'*.

There are a three short educational lessons, links to the Webinars (4th October and 14th November), the service specification and some FAQs.

(Repeat message) Treatment of C Difficile Infection (CDI)

We recently audited all patients in Ayrshire and Arran who had CDI between April and June 2023. The audit highlighted an occasion where a patient had been prescribed vancomycin 125mg orally to treat the CDI. The community pharmacy team contacted the GP practice to confirm the indication and advised that they did not have any vancomycin capsules in stock and it was not cost effective. As a result, the prescription was changed to metronidazole.

Our guidelines were reviewed in 2022 and metronidazole was removed as a first line treatment for CDI. The first line treatment is vancomycin 125mg orally every 6 hours for 10 days.
