1. EXECUTIVE SUMMARY

NHS Highland and Strathspey Pharmacy undertook a joint public consultation exercise with regard to Strathspey Pharmacy's intention to open a new pharmacy in the Newtonmore area at Ashdown, Main Street, Newtonmore. PH20 1DN.

Carrying out a joint consultation during the pre-application phase has been a requirement of the NHS (Pharmaceutical Services)(Scotland) Regulations 2009 since 2014. The Regulations set out the requirements for the consultation process and these have been followed by both parties.

The purpose of the joint consultation was to seek views of local people as to whether they think they have adequate access to pharmacy services in the area, and to measure the level of local support for the potential of a new pharmacy in the area.

A joint consultation and engagement plan was agreed between NHS Highland and Strathspey Pharmacy with the knowledge of the Scottish Health Council. The consultation was required to run for 90 working days and took place from 24th July, 2019 to 19th November, 2019 (allowing for Public Holidays during that time).

Survey responses were received from 129 people; 28 via paper copy questionnaire and 101 via electronic Survey Monkey. Based on all the feed-back there was a strong consensus across all elements of the consultation fed-back:

Q1. There was agreement that the proposed boundary accurately described the neighbourhood (90%)

Q.2. There was agreement that the proposed location at Newtonmore is appropriate

to meet the needs of the neighbourhood (92%)

Q.3. 85% of the responders live in the neighbourhood.

Q.4. The hours being proposed were supported (90%)

• Q.5. 81% felt that the current provision of pharmacy services was not adequate in

the area (102 responses)

Q.6. 86% agree that it is necessary to approve a pharmacy application in the neighbourhood to ensure pharmaceutical services are adequately provided (102 responses)

Q.7. 77% felt that the proposed pharmacy would positively impact on other

healthcare providers

Q8. 80% felt that the proposed application would help to foster improved joint working across other health care providers

This summary report has been prepared jointly by NHS Highland and Mr. A. Horsburgh.

On completion of this report the Applicant will then decide whether or not they wish to submit an application under the Regulations to NHS Highland to open a pharmacy in Newtonmore.

INTRODUCTION 2.

The NHS (Pharmaceutical Services) (Scotland) (Miscellaneous Amendments) Regulations 2014 introduced a change to previous consultation arrangements for applications to join the Board's Pharmaceutical List.

Under the new arrangements, parties are required to carry out a joint consultation, and the Regulations set out the requirements to be followed.

Tornagrain Healthcare Ltd held an initial meeting with NHS Highland in November 2018 to discuss the intention to open a new pharmacy in Newtonmore. The proposed opening times would be:

Monday - Friday

9.00 am - 6.00 pm

Saturday

9.00am - 1.00pm (winter)

9.00 am - 5.00 pm (summer)

Sunday

Closed

This report summarises the approach and findings from developing the consultation plan through to describing the consultation feedback, which ran for 90 working days from 24th July, 2019 to 19th November, 2019 (allowing for Public Holidays during this time).

3. AIMS

The aims of the process were to agree a joint consultation plan, carry out a joint consultation exercise and report on the findings.

Specifically in terms of the scope of the consultation the aim was:

- to seek views of local people as to whether they feel they have adequate access to pharmacy services in the area,
- to measure the level of support for the potential new pharmacy in the area

4. METHODOLOGY

4.1 Communications and engagement plan

Meetings took place between representatives of NHS Highland and Strathspey Pharmacy to discuss how to take forward the pre-application joint consultation. This included briefings on the Regulations, the Board's Hours of Services Scheme and specifically any requirements regarding the consultation and consultation process.


Further discussions took place and a communications and engagement plan was developed which set out initial planned activities. Advice was sought from Scottish Health Council and The Chair of the NHS Highland Pharmacy Practices Committee (PPC) was informed of the likelihood of an Application.

The Action Plan was agreed by NHS Highland and Strathspey Pharmacy (Appendix 1). It was understood that the plan would be further developed, as required, to respond to any requests or address any emerging gaps in the plan but that any additional activity would be jointly agreed.

The joint approach to the consultation between NHS Highland and Strathspey Pharmacy was agreed by both parties through written communication.

4.2 Defining location

Pre-work identified included preparing a map to define the proposed neighbourhood for a new pharmacy. The defined neighbourhood would be served by the proposed pharmacy site as the area within the area highlighted by the red border in the map shown below, indicating the exact location of the proposed new pharmacy.



4.3 Pre-consultation activities

Other pre-consultation activities included identifying potential interested parties and other stakeholders, preparing communication materials and developing a NHS Highland website presence.

A consultation questionnaire (Appendix 2) was also prepared to comply with the requirements of the regulations. It was split into five sections:

Section A - Location

Section B - Opening Times

Section C - Views on adequate provision of pharmacy services

Section D - Wider Impact

Section E - Contact Information

All consultation materials were signed off by both parties. This was made available to the general public along with an explanation of the Regulations process.

4.4 Raising awareness of the consultation

The plan was split into phases to ensure a good spread of activity throughout the consultation period and to plan a balance of activities to be carried out by NHS Highland staff and the potential applicant. There was regular dialogue throughout the process between NHS Highland and Mr. A. Horsburgh.

Various approaches were used to raise awareness including a Press Release (see Appendix 3) - this is a formal requirement of the Regulations, to announce the consultation and ongoing social media including Facebook and Twitter.

The Applicant attended the Newtonmore Community Council meeting on 7th October and provided information about the application process, the timescales involved and examples of the services to be provided.

4.5 Consultation survey response form

The consultation questionnaire was available via a link on the home page of NHS Highland website:

The survey could also be completed on-line with paper copies available from NHS Highland as well as the Applicant via his website. Printed forms and a stamp addressed envelope for return to Assynt house were provided at the local Post Office. The survey documentation (and communication materials) also provided contact details for NHS Highland for anyone wishing support to complete the survey or requiring further advice. Members of the public could also telephone NHS Highland for a paper copy as well as a large font questionnaire. A total of 50 hard copies were printed and sent to the Applicant for distribution.

5. RESULTS

5.1 Responses to survey

The total number of responses received totalled 129; 101 from the electronic Survey Monkey and 28 paper submissions. 123 responses were from individuals (not on behalf of groups) and 3 from an organisation representative. The information gathered from the survey is summarised below with the full responses available (Appendix 4).

Section A - Location

A key part of the consultation was to determine that there was good understanding and agreement about the boundary for the proposed new pharmacy.

Q1. Do you agree the boundary of Newtonmore (above) describes the neighbourhood?

Yes – 116, No - 5, Don't know – 7, Not answered – 1

Most responders agreed the boundary describes the neighbourhood, with agreement this is a rural area; distance and travel being a challenging aspect for the residents currently.

Q.2. Do you agree the proposed location at Newtonmore is appropriate to meet the needs of the neighbourhood?

Yes -119, No -8, Don't know -2

There was positive interest in its location, many responders highlighting the site being conveniently situation, travel issues and access particularly for the elderly. However, there was concern expressed over security issues.

Q.3. Do you live in the neighbourhood within the dark border on the map?

Section B - Opening times

Q.4. Do you agree the proposed hours are appropriate to the needs of the neighbourhood?

Yes - 116, No - 9, Don't know - 4

Most responders considered the proposed opening hours to be of particular benefit to commuters, however, Saturday/Sunday opening hours could perhaps be considered in view of the 5.30 pm closure of local GP surgeries if travel involved.

Section C - Views on adequate provision of pharmacy services

Q.5. Do you agree there are gaps/deficiencies in the existing provision of pharmaceutical services to the neighbourhood? Yes – 105, No – 10, Don't know – 14, Not answered – 1

There were many comments suggesting an alternative to the current local pharmacy would be welcomed, particularly offering a wider range of services. Although some comments suggested an ample sufficiency in the area, the lack of local support for elderly was highlighted.

Q.6. Do you agree it is necessary to approve a pharmacy application in the neighbourhood to ensure pharmaceutical services are adequately provided? Yes -112, No -9, Don't know -9

Responders were unanimously in favour of additional pharmacy in the area due to challenging factors relating to rural area i.e. lack of public transport, local support, elderly population. However, a minority of responders were of the opinion services were adequately covered.

Section D – Wider impact

Q.7. In your opinion would the proposed pharmacy **help** other healthcare providers to work closer together i.e. GPs, community nursing, other pharmacies, dentists, optometrists and social services? Yes -99, No -11, Don't know -17, Not answered 1

There were mixed responses relating to the service already provided, future needs and care of the elderly. Some responders felt there was sufficient provision.

Q.8. In your opinion how would the proposed pharmacy **impact** on other healthcare providers i.e. GPs, community nursing, other pharmacies, dentists, optometrists and social services?

Positive – 103, Negative – 11 Don't know – 13, Not answered 2

Not appropriately answered, however, similar concerns were expressed i.e.

care of the elderly, additional service opportunity for the public and travel issues relieved. Once again, concern expressed over security of the building.

Q.9. Please write any other comments you may have ?

The final question (Q9) provided an opportunity for people to provide any other comments, and many took the opportunity to provide further comments. Most of the views expressed were favourable towards the application and reflected feedback from young people with families as well as the elderly population. Their comments included positive impact on the community, negating the need to rely on public transport, imminent closure of the local hospital, frequent double journeys required to drop off and pick up prescriptions, tourists, easing the burden on adjacent pharmacies. However, a few responses highlighted there to be no need or desire for an additional local pharmacy.

Q.10. Are you replying on behalf of individual or organisation? Individual – 123, Organisation – 3, Not answered - 3

5.2 Other written responses

6. CONCLUSIONS

The challenge of a consultation is always to reach as many interested parties as possible, to give them the opportunity to state their views. A wide ranging approach was used including local media coverage and local mail drops. An approach was extended to Scottish Health Council for comments, however to date no reply has been received.

Introduction

Under the National Health Service (Pharmaceutical Services) (Scotland) Regulations 2009 as amended, Strathspey Pharmacy intends to submit an application to be located at Main Street, Newtonmore.

Before any application is made Strathspey Pharmacy and NHS Highland are required to undertake a joint consultation exercise. The purpose of the consultation is two-fold:

- to seek views of local people as to whether they feel they have adequate access to pharmacy services in the area,
- measure the level of local support for the potential new pharmacy in the area

The joint consultation must run for at least 90 working days from the start date of the advertisement.

The potential applicant will then have 90 days (not working days) from the end of the joint consultation submit their application to the Secretary to the Pharmacy Practices Committee, NHS Highland, Assynt House, Inverness, IV2 3BW

This document sets out the initial planned activities to underpin communications and engagement around the public consultation. It has been agreed by NHS Highland, Tornagrain Healthcare Limited, the applicant and Scottish Health Council. 



SECTION C: PHARMACEUTICAL SERVICES

Strathspey Pharmacy proposes to provide all core, local, national and additional pharmaceutical services as listed below:

Core:

• Minor Ailment Service (MAS): Certain groups of patients can register with the community pharmacy of their choice to enable them to consult with a community pharmacist for certain minor conditions from the pharmacy free of charge. The pharmacist advises, treats or refers the individual according to their needs.

Acute Medication Service (AMS): This is the dispensing of acute or "one-off" prescriptions but supported by the electronic version of the prescription, to increase

patient safety, improve data collection and payment processes.

• Medication; Care Review (MCR) - (previously known as CMS - Chronic Medication Service): For patients with long term conditions where pharmacists can provide an assessment of your medicines which includes any particular medicines related risks. MCR includes the ability to provide a serial prescription over the course of 6 months or a year to patients without the patient requiring to contact their GP practice for these items during this time period.

Public Health Service (PHS): Patients can access their local community pharmacy

for self-care advice, support and information on health issues. This includes a smoking cessation service to help those who wish to stop smoking and a sexual health service which includes free access to Emergency Hormonal Contraception (EHC).

• Gluten Free Food Service (GFFS) – Those patients with a confirmed diagnosis of Coeliac Disease or dermatitis herpetiformis by their GP can register with a pharmacy of their choice to obtain GFF food items in accordance with the Highland GFFS Formulary (an agreed list of foods that the NHS consider as essential).

- Advice to Care Homes
- Buprenorphine Dispensing & Supervision
- Care at Home
- Methadone Dispensing & Supervision
- Needle Exchange Services
- Palliative Care
- Pharmacist Prescribing Clinic

National Services (requiring local agreement):

- Enhanced pharmaceutical Care/Pharmacy First: Urinary Tract Infection (UTI) & Impetigo Treatment
- Medication Compliance Support Service Device (Blister Pack)
- Unscheduled Care: Urgent Supply of Medication

Community Pharmacy Newtonmore Application Public Consultation Process

What is this about?

If somebody wants to open a new community pharmacy and make up NHS prescriptions, and the other services which go along with this, they have to apply to the Health Board.

The Scottish Government decide what rules have to be followed. The person who wants to open the pharmacy has to follow strict rules about how they go about applying to the Health Board.

The Health Board also has to follow rules about how they decide whether a new pharmacy is necessary or not. Part of what they have to do is carry out what is called a joint consultation in conjunction with the person who would like to open a new pharmacy. The rules state that the people who live in the area must be asked what they think about a possible new pharmacy and informed of its possible location. They are also asked what they think about the service they receive from the other existing pharmacies in the surrounding area. The consultation process lasts for 90 working days starting on 15th July, 2019 and closing on 19th November, 2019. No responses can be accepted after 5pm on the closing date.

A special committee called the Pharmacy Practices Committee (PPC) is formed for each new pharmacy application and they have to decide whether or not a new pharmacy is necessary based on all the facts. The committee will determine whether residents feel they already have adequate access to pharmacy services in the area and will also gauge the support for the application. Views submitted will be incorporated into a Consultation Analysis Report which will be taken into account by the NHS Highland PPC which decides the outcome of an application.

What can you do?

We really need you to fill in a consultation questionnaire and return to the address below by 19th November, 2019. We want to know what local people think about the idea of a new pharmacy and whether you support it or not. We also want to know what you think about the pharmacy services that are already being provided to the area and whether they meet the needs of the local people. The consultation is available on-line or you can fill in a paper copy if you prefer.



Pharmacy application

Strathspey Pharmacy intends to submit an application to NHS Highland to open a new pharmacy at Main Street, Newtonmore.

NHS Highland and Strathspey Pharmacy are undertaking a joint consultation exercise to seek the views of local people who may be affected by this, or use the pharmacy at its proposed location, to determine whether residents feel they already have adequate access to pharmacy services in the area and to gauge support for the application.

The consultation process will last for 90 working days beginning on Monday, 15th July 2019 and closing on Tuesday, 19th November 2019. No responses can be accepted after 5pm on the closing date.

- My GP takes appointments to 6pm on a Tuesday and Friday but you cannot get to the pharmacy as it closes at 5.30. Plus it's a 22 mile return journey for me which takes just over 20 minutes each way.

5. Do you agree that there are gaps/deficiencies in the existing provision of pharmaceutical services to the neighbourhood?

- The impression from the community is that Boots feel they have a monopoly and therefore don't provide some of the services proposed

- There were two chemists in Newtonmore not so long ago.
- Please see above answer
- Boots (nearest pharmacy to Newtonmore) in Kingussie not always reliable.
- Have covered this in answer to next question.
- The chemist in Kingussie often makes mistakes dispensing medication or often doesn't have the medication you need in stock meaning you have to make a lengthy trip again to collect your medication
- I'm not in a position to say if the current ones provide the above or not.
- Considerable distance to travel and now delivery charges for prescriptions might be removed.
- In the event Boots doesn't have a prescribed medicine it would be beneficial to have local alternatives.
- Only those with access to own transport, or very few buses can reach Kingussie pharmacy.
- Limited medications, often don't have what Dr has prescribed and alternatives have to be sourced
- Being Kingussie as the nearest people who cannot drive are left having to rely on public transport to get to the pharmacy which in this area isn't the most reliable especially in winter times
- Unless you drive it can be very difficult to get to Kingussie on public transport when it suits
- There are no pharmaceutical services in the area described at present, the nearest being in Kingussie (Boots) necessitating a bus / train / car journey to collect medication. The service at that store has become increasingly unreliable and on three separate occasions I have been unable to pick up a repeat prescription due to the pharmacist "not arriving" and the store being closed.
- Not always possible to see GP when needed having this extra service I feel would be beneficial and possibly help ease workload at local surgeries
- It's currently not accessible to everyone
- In that some people have to travel a distance to get to their pharmacy
- Nothing here in the village if you need anything in an emergency you have to get someone to take you to Kingussie as no taxi service
- See no 6 transport into Kingussie difficult, no local delivery service, frequent out of stock items requiring repeat trips.
- I believe that there are sufficient services in this area.

- Never heard of those services. I am waiting for a pillbox for my wife and I need to pay for a delivery.
- Can't get medicines, have to wait ages to get served, the service is shocking
- The pharmaceutical services in Kingussie are covering a large area with many complex needs, from what I've seen they are struggling to meet the needs.
- The current local pharmacy doesn't carry all the services listed above ie Needle exchange, stoma service, prostate cancer dispensing
- People living between Kingussie and Pitlochry don't have access to a pharmacist
- The present pharmacy has no time for people. They have a consulting room but never use it for people to speak to the pharmacist with private matters.
- Already provided in Kingussie.
- I have no personal experience of gaps
- The pharmacy at Kingussie does a reasonable job of serving the community. I might like to see a delivery service for elderly or disabled people, but appreciate the distances involved would make this time consuming for the pharmacy staff could an imaginative solution be found? If you are driving to Kingussie currently, it doesn't make a big difference to drive to Newtonmore. There is still no public transport option for many people. However, if the pharmacy at Kingussie was to close, this would leave a huge gap as the nearest pharmacy would be Aviemore.

Many (older) Strathspey residents do not have their own transport. Public transport is limited. Pharmaceutical services in Newtonmore would fill a big gap n services/provision locally
- Sometimes the service in Boots the Chemist Kingussie leaves a lot to be desired 3-4 people counter, all seemingly busy but leave customers standing waiting not good. Perhaps not coping, don't know?
- I cannot say what there are deficiencies are in our present pharmacy. On the contrary the staff and pharmacist are caring and obliging. It's purely the distance involved for collection.
- For those without a car have 6 miles to go to the Kingussie pharmacy & there is no taxi service or regular bus/train service - very limited. I operate a B&B and guests ask if the village have a chemist. They are shocked & disappointed they have to travel.
- Getting there. Public travel in the neighbourhood is poor.
- E.g. the local Boots pharmacy won't dispose of unwanted asthma devices. And there is no one in the village of Newtonmore to give advice to the elderly who can't travel to Kingussie.
- As a resident in Newtonmore using Laggan medical Practice, I don't go to Kingussie very often. Pharmacy would be a necessary addition to the village.
- As much as you need to drive to Kingussie. Or if you don't drive or are too elderly you need to pay!!
- Not always convenient to travel to Kingussie.
- The pharmacy/chemist shopping Kingussie run by Boots mainly has the same practising pharmacists on duty. It is a longer round drive or bus trip (a few a day) to get too
- For those of us who are aging, a car may not always be our usual form of transport and with very poor public transport available it will be difficult in the future to collect our prescriptions.
- Elderly people without transport have to go to Kingussie.

- Yes. As people can't always get to Kingussie without a car.
- We have to travel outside the area to Kingussie currently.
- Healthcare in the area is already second to none. Between official health service offerings, Boots, and the most importantly community. Community is everything in the village; everybody looks out for each other.

6. Do you agree that it is necessary to approve a pharmacy application to ensure pharmaceutical services are adequately provided in the proposed neighbourhood?

- See answer to No 4. Details identical but I'd be happy to visit private friendly pharmacy as opposed to big guns.
- Especially as boots have a monopoly within a 30 mile radius, and they are considering closing branches.
- It is the case that there was once a pharmacy here when Newtonmore was smaller.
- Yes- these services should be adequately provided. Appropriate check/approvals are essential. But the needs of the local people are paramount. NHS should be constantly aware of the pressures & challenges people living in remote areas and should do all they can to support small communities.
- As above elderly struggle on a bus having to go to Kingussie chemist some cannot but am sure it would massively help having chemist here. We need an independent pharmacy.
- To know that your pharmacy is within a reasonable distance can only be reassuring.
- A necessity for this neighbourhood.
- It's important to regulate pharmaceutical services & also to ensure a neighbourhood is well catered for
- Definitely.
- To ensure compliance with professional standards.
- Obviously professional standards must apply.
- Sadly I know of several instances of prescriptions not always made accurately & people's health has suffered in the past. In an ageing population it is not always possible to check on the dosage each time a repeat prescription is supplied
- For legal reasons!
- Most definitely.
- Don't understand the question
- More than adequate cover already. Prescriptions will be delivered directly within 10 yrs. Multiple companies already provide this service.
- 7. In your opinion would the proposed pharmacy help other health or social care providers to work closer together i.e. GPs, community nursing, other pharmacies, dentists, optometrists and social services (care homes, care at home etc)?
- I can't see how it could go wrong but maybe you need in depth discussion with present one in Kingussie i.e. Are we all happy working for you???
- I would assume so but hardly qualified to answer such a question.
- Another pharmacist would enhance the areas ability to serve the community.
- We do have a care home in the area. The proposed pharmacy would be of help to them, I am sure. We also have an ageing population, supported by care providers,

- local medical practices, visiting doctors & support workers. All would benefit.
- Am quite sure it would make a difference to core workers etc. Much handier to go to pharmacy locally than go back and fore to Kingussie. We have the Mains Care home and Hanover sheltered housing.
- For the reasons detailed in the above.
- For certain.
- Ageing and growing population requires this.
- There is a local care home as well as many elderly people living alone with no transport & no family support.
- · Not a healthcare provider, can't answer it!
- I would hope so!
- Would provide a more localised and hopefully helpful service.
- I would definitely think so.
- As well as the residents of Newtonmore there is a large care home in the village which I feel sure would appreciate a local pharmacy.
- Providing a local service.
- Yes I do.
- Again in need of care/attention could be seen at chemist first for assessment which
 would take the pressure of surgery in Kingussie plus there is community nursing etc
 will have a communal point of correlation with chemist in Newtonmore + other
 services for the wider area of the 'neighbourhood'
- · Save time, save fuel, easier for older people.
- We have the best already.
- 8. In your opinion how would the proposed pharmacy impact on other health and social care providers i.e. GPs, community nursing, other pharmacies, dentists, optometrists and social services (care homes, care at home etc)?
- Answer speaks for itself. I can only say panic with child or older person. Pharmacist on hand if surgery closed.
- More choice, options I would assume.
- I believe a new pharmacy in Newtonmore would benefit GPs, community nurses & social services. We have a large care home in the village. Also a growing number of older people who need care in their own homes. A local pharmacy would have a positive impact on all of those support services
- As before it can only help.
- I am sure that to take the pressure off an already busy pharmacy can only be an advantage.
- Surely it can only be positive.
- It will be closer for residents of Newtonmore walking distance and also closer for Laggan, Dalwhinnie & surrounding area. And closer for the Gergask practice, Laggan.
- They need support at all times.
- There would be local continuity of care. The Boots pharmacy has several
 pharmacists working there so they can't get to know the local folk well enough to be
 of assistance.
- Would offer a more convenient alternative & encourage competition.

- It can only be to the good of all organisations'.
- "Elderly people without computers have to travel to Kingussie to hand in prescription & 3 days later return to ""pick up"""
- I'm sure it would be helpful for all.
- We have our care home + one assisted living/independent home in the form of Glen Grove which would benefit greatly from a dispensing chemist in Newtonmore. It would also benefit anyone else in need including the many tourists who holiday here but don't have their own transport while here.
- Will certainly help the elderly in the community and those without transport.
- Save time on GP visits, save fuel. Improve rural living.
- No difference.

9. Any other comments

- Privacy important to most older folks. The way things are handled or questioned can be off putting. Lovely to be able to shop for our whatever's in our village in really bad weather and older folks can walk and enjoy the experience of even talking with someone.
- The applicant already runs two independent pharmacies in the Highlands. This, I believe, gives him the experience/knowledge to know if this is a viable business proposal.
- This area of Strathspey misses out by not having a community pharmacy. Local people struggle with lack of public transport. Many families/older people do not have their own transport and rely on others to help them. The largest population settlement is in Newtonmore. I think a pharmacy in the middle of the village would be well used and well supported. It would bring many benefits to the local community especially in terms of the extra services it could offer. As hospital support will soon be based in Aviemore, this is yet another reason why small semi-isolated rural communities should be supported by NHS decisions. (As hospital in kingussie closes)
- As an older member of the community I would find having a pharmacy in Newtonmore very helpful. I do not have computer skills or my own transport so have to rely on local buses which are not too frequent to get my prescriptions to the surgery and have only recently had the help of home delivery so a local pharmacy would be a huge help. Thank you.
- I believe Boots are going to charge for delivering prescriptions, so I would certainly
 think it would be in the village etc best interest to have pharmacy here in
 Newtonmore. Boots stopped it going ahead before which was ridiculous.
- In my own personal situation as an 84yr old who is caring for her 80yrs old husband, I rely on the kindness of my good neighbours to collect medication weekly which works well as an agreement between the pharmacy, surgery and myself and I would hope that should this pharmacy become accepted, such arrangements will be allowed to continue for my benefit and that of others in a similar situation.
- The pharmacy at Boots is just not set up for rural living. I know many elderly people that have problems getting to Kingussie from Newtonmore due to our inadequate public bus service. Added to that the number of times my own dad has had to go back in because there's an item missing. It's a very poor service and anything that

- could improve it would be a blessing.
- For me, my family and friends in Newtonmore means a more convenient place to collect prescriptions and toiletries etc. My B&B guests will be better served for any medication etc they require. Prescriptions from Boots, Kingussie can often be wrong which is frustrating & leads you to order prescriptions in advance.
- This form, while I know it needs to be thorough, has been quite intimidating for elderly people to answer so you may not get a comprehensive response from the very people the pharmacy would serve. Parking is an issue in Kingussie & the pharmacy in Newtonmore would be much more accessible to if parents with small children, with the local nursery + primary school adjacent.
- Hope this application succeeds where the earlier one by Gerrard Samson/Oakers failed.
- I do feel this questionnaire may not do its job as at a glance it looks complicated i.e.

 asking to explain your answer. People may be put off + won't bother. I really hope
 it is not true and it goes ahead! With an ageing population it would be wonderful just
 to walk along the street and get help with minor ailments for children as well as
 adults + lessen the GPs work load!
- Current provisions in Kingussie are not always convenient. The service is adequate rather than outstanding. Often pushing its own services rather than integrating into the wider medical landscape.
- it would only benefit the neighbourhood at Newtonmore in particular to open a
 pharmacy retail chemist as another shop opening in Newtonmore would be
 beneficial to our excellent post office shop which will soon be the only post office in
 Badenoch & Strathspey, I am certain this new enterprise will be a great success
 especially in view of the shortcomings at Boots Kingussie
- It has been many years since the village has had a chemists shop. It will provide a service of everyday toiletries etc as well as the pharmacy. It will be WONDERFUL!
- The community pharmacy in Newtonmore would be so helpful, & I'm sure it would be used 100% in this area.
- It would take the pressure of Kingussie & be beneficial to anyone who just wants
 medication to treat minor ailments or repeat prescription without having to travel to
 Kingussie which is a long few miles in the winter when/if no transport.
- · Think it is a good idea as long as it doesn't impact on the chemist in Kingussie
- As the owner of the property directly above the proposed site, I am deeply concerned about the suitability of the building. It has 5 doors, 2 of them in a worryingly secluded area. There are also 3 windows at the rear, again completely secluded. It would surely be a target for crime. The local police say it could potentially take them 45 mins to attend any incidents. Also the property is in a boundary dispute, this is likely to end up in a lengthy legal battle.
