#### 1. EXECUTIVE SUMMARY

NHS Highland and Highland Pharmacy undertook a joint public consultation exercise with regard to Highland Pharmacy intention to open a new pharmacy in the Cradlehall area of Inverness – 7 Cradlehall Court, Cradlehall. IV2 5WD (a.k.a. Unit 4 Cradlehall Shopping Centre, Cradlehall. IV2 5WD).

Carrying out a joint consultation during the pre-application phase has been a requirement of the NHS (Pharmaceutical Services)(Scotland) Regulations 2009 since 2014. The Regulations set out some requirements for the consultation process and these have been followed.

The purpose of the joint consultation was to seek views of local people as to whether they think they have adequate access to pharmacy services in the area, and to measure the level of local support for the potential of a new pharmacy in the area.

A joint consultation and engagement plan was agreed between NHS Highland and Highland Pharmacy with advice sought from the Scottish Health Council.

The consultation was required to run for 90 working days and took place from 1<sup>st</sup> October, 2018 to 8<sup>th</sup> February, 2019 (allowing for Public Holidays during that time).

Survey responses were received from 766 people; 504 via paper copy questionnaire and 262 via electronic Survey Monkey. Based on all the feedback there was a strong consensus across all elements of the consultation fedback:

- There was agreement that the boundary accurately described the neighbourhood (92%)
- There was agreement that the proposed location at Cradlehall Court is appropriate to meet the needs of the neighbourhood (90%)
- The hours being proposed were supported (86%)
- 81% felt that the current provision of pharmacy services was not adequate in the area
- 77% felt that the proposed application would help to foster improved joint working across other health care providers
- 77% felt that the proposed pharmacy would positively impact on other healthcare providers
- 84% agree that it is necessary to approve a pharmacy application in the neighbourhood to ensure pharmaceutical services are adequately provided

This summary report has been prepared jointly by NHS Highland and Mr. Mo Ameen of Highland Pharmacy.

On completion of this report the Applicant will then decide whether or not they wish to submit an application under the Regulations to NHS Highland to open a pharmacy in Cradlehall Court, Inverness.

#### 2. INTRODUCTION

The NHS (Pharmaceutical Services) (Scotland) (Miscellaneous Amendments) Regulations 2014 introduced a change to previous consultation arrangements for applications to join the Board's Pharmaceutical List.

Under the new arrangements, parties are required to carry out a joint consultation and, the Regulations set out some requirements to be followed.

Highland Pharmacy held an initial meeting with NHS Highland in July, 2018 to discuss the intention to open a new pharmacy in the Cradlehall area of Inverness (Cradlehall Court). The proposed opening times would be:

Monday - Friday 8.30am – 6.00pm (open during lunch)

Saturday 9.00am – 1.00pm

Sunday Closed

This report summarises the approach and findings from developing the consultation plan through to describing the consultation feed-back, which ran for 90 working days from 1<sup>st</sup> October, 2018 to 8<sup>th</sup> February, 2019 (allowing for Public Holidays during this time).

#### 3. **AIMS**

The aims of the process were to agree a joint consultation plan, carry out a joint consultation exercise and report on the findings.

Specifically in terms of the scope of the consultation the aim was:

- to seek views of local people as to whether they feel they have adequate access to pharmacy services in the area,
- to measure the level of support for the potential new pharmacy in the area

#### 4. METHODOLOGY

#### 4.1 Communications and engagement plan

Meetings took place between representatives of NHS Highland and Highland Pharmacy to discuss how to take forward the pre-application joint consultation. This included briefings on the Regulations, the Board's Hours of Services Scheme and specifically any requirements regarding the consultation and consultation process.

Further discussions took place and a communications and engagement plan was developed which set out initial planned activities. Advice was sought from Scottish Health Council and The Chair of Pharmacy Practices Committee (PPC) was informed of the likelihood of an Application.

The plan was agreed by NHS Highland and Highland Pharmacy (Appendix 1). It was understood that the plan would be further developed, as required, to respond to any requests or address any emerging gaps in the plan but that any additional activity would be jointly agreed.

The joint approach to the consultation between NHS Highland and Highland Pharmacy was agreed by both parties through written communication.

#### 4.2 Defining location

Pre work indentified included preparing a map to define the neighbourhood. The defined neighbourhood would be served by the proposed pharmacy site as the area within the area highlighted by the red border in the map shown below indicating the exact location of the proposed new pharmacy.



#### 4.3 Pre-consultation activities

Other pre-consultation activities included identifying potential interested parties and other stakeholders, preparing communication materials and developing a NHS Highland website presence.

A consultation questionnaire (Appendix 2) was also prepared to comply with the requirements of the regulations. It was split into five sections:

Section A – Location

Section B – Opening Times

Section C – Views on adequate provision of pharmacy services

Section D - Wider Impact

Section E - Contact Information

All consultation materials were signed off by both parties.

#### 4.4 Raising awareness of the consultation

The plan was split into phases to ensure a good spread of activity throughout the consultation period and to plan a balance of activities to be carried out by NHS Highland staff and the potential applicant. There was regular dialogue throughout the process between NHS Highland and Highland Pharmacy.

Various approaches were used to raise awareness including an advert in the local papers (28.9.18) - this is a formal requirement of the Regulations, a series of media releases (see Appendix 3A) to announce the consultation and the reminder on 21.1.19 (see Appendix 3) as the consultation entered its final 2 weeks), and ongoing social media including Facebook and Twitter (see

Appendix 3A).

A number of local engagement events and meetings also took place including community council meetings. The applicant visited Cradlehall Primary School, two Nurseries and Cradlehall Nursing Home. The Community Council held monthly meetings where the public consultation was discussed.

There was media interest in the consultation throughout the process and a selection of cuttings are provided (Appendix 3A). There was also a range of online and social media coverage.

#### 4.5 Consultation survey response form

The consultation questionnaire was available via a link on the home page of NHS Highland website:

The survey could also be completed on-line with paper copies available from various personnel i.e. the local Community Councillor and the Applicant. The Chair of the Community Council placed notices of the pharmacy consultation in the community Noticeboards in Cradlehall and Westhill. The survey documentation (and communication materials) also provided contact details for NHS Highland for anyone wishing support to complete the survey or requiring further advice. Members of the public could also telephone NHS Highland for a hard copy and a prepaid envelope to return responses as well as a large font questionnaire. Paper copies were also delivered to various retail outlets including the school and Care Home in Westhill by the Community Councillor. The local primary school and local shops agreed to act as return points. Pickups were carried out by the Community Councillor and the Health Board. A total of 1700 hard copies were printed and 100 pre-paid envelopes were given to the Applicant for distribution.

#### 5. RESULTS

#### 5.1 Responses to survey

The total number of responses received totalled 766; 262 from the electronic Survey Monkey and 504 paper submissions. (7 late responses were received and not included). 714 responses were from individuals (not on behalf of groups) and 11 from an organisation representative. (41 did not respond to this question). The information gathered from the survey is summarised below with the full responses available (Appendix 4).

#### Section A - Location

A key part of the consultation was to determine that there was good understanding and agreement about the boundary for the proposed new pharmacy.

Q1. Do you agree the boundary of Cradlehall and Westhill (above) describes

the neighbourhood?
Yes – 705, No - 24, Don't know – 27
```

There was general agreement with the boundary outlined in the questionnaire. However, a small number of responses indicated that the boundary should not extend as far as the A9.

Q.2. Do you agree the proposed location at Cradlehall Court is appropriate to meet the needs of the neighbourhood? Yes – 693, No – 55, Don't know – 9

A large number of the public felt the close proximity to local amenities was an advantage. A number of respondents commented that the location of the proposed pharmacy would mean they wouldn't need to make unnecessarily lengthy journeys thus also avoiding the expense of double journeys in the event of part-dispensing. It was felt that the Care Home would also benefit. However, a number of responders were concerned about the potential links to drug abuse with the close proximity of the local Primary School and Nursing Home. Limited parking was also highlighted as a potential problem. Some responders felt there was sufficient provision in the area to meet the current needs.

Q.3. Do **you** live in the neighbourhood within the dark border on the map? Yes – 680, No - 72

705 out of 766 (92%) of respondents agreed that the area highlighted in the consultation map described the neighbourhood. 693/766 (90%) also felt that the location of the proposed new pharmacy (Cradlehall Court) was appropriate to the needs of the neighbourhood with local conveniences highlighted as it was near local amenities. Most respondents 680/766 (88%) also confirmed that people living within the area highlighted would consider themselves to be living in the neighbourhood.

#### Section B - Opening times

Q.4. Do you agree the proposed hours are appropriate to the needs of the neighbourhood?

Yes - 657, No - 59, Don't know - 28

657 out of 766 (86%) people who responded thought the hours being proposed (Mon-Fri 8.30am - 6.00pm and Sat 9.00am – 1.00pm) were appropriate to the needs of the neighbourhood.

The majority of positive responses felt the proposed hours were adequate to meet most needs. A few felt that additional opening hours on a Saturday and limited opening hours on a Sunday could prove beneficial.

#### Section C - Views on adequate provision of pharmacy services

Q.5. Do you agree there are gaps/deficiencies in the existing provision of

pharmaceutical services to the neighbourhood? Yes – 622, No – 72, Don't know – 53

A large number of responders expressed concerns regarding the current burden of travel distance and consequent expense to their nearest pharmacy for the elderly population. A few comments received intimated there were sufficient pharmacies currently in the area.

**Q.6.** Do you agree it is necessary to approve a pharmacy application in the neighbourhood to ensure pharmaceutical services are adequately provided? Yes – 643, No – 62, Don't know - 37

Questions were asked about the current adequate provision of core and locally negotiated pharmaceutical services. 622 (81%) responded positively that there were gaps/deficiencies, however 16 did not respond. Key issues highlighted by those who responded included a lack of services in the local area and difficulties in accessing services outwith the local area due to lack of personal or public transport.

84% felt that it would be necessary to approve the application in the neighbourhood to ensure adequate provision. 8% felt it was unnecessary.

There was great concern with regard to the elderly in the neighbourhood; the lack of regular public transport sometimes necessitating expensive taxi fares. There was concern over undue burden being placed on the surrounding pharmacies, these pressures potentially increased when considering the expected housing development growth of the surrounding area. Concerns were expressed about the potential drug misuse related issues particularly being so close to the Primary School and Care Home and feeling there was sufficient provision in the area.

#### Section D – Wider impact

**Q.7.** In your opinion would the proposed pharmacy **help** other healthcare providers to work closer together i.e. GPs, community nursing, other pharmacies, dentists, optometrists and social services? Yes -586, No -63, Don't know -97

With regard to whether the proposed pharmacy would help other healthcare providers work closer together, a number of responders felt the close proximity of the Care Homes could have a positive impact as well as easing the burden on the GP surgery. However, concern was expressed with regard to the fact there isn't a GP surgery closer to Cradlehall which would be a welcomed development. A number of responders claimed their lack of knowledge made this a difficult question to answer.

**Q.8.** In your opinion how would the proposed pharmacy **impact** on other healthcare providers i.e. GPs, community nursing, other pharmacies, dentists, optometrists and social services?

Positive – 594, Negative – 41, Don't know – 98

It was felt by 586 of those who responded (76%) that the proposed application would help to foster improved joint working between other health care providers (GPs, community nursing, dentists, optometrists and social services). A further 97 (13%), however, felt they had insufficient knowledge to comment. 594 (77%) felt the proposal had the potential to impact on other healthcare providers while 5% did not feel it would; a further 13% stated they 'didn't know'.

Most of the responses were positive, in particular easing the burden on the local GPs. A few comments were received from responders indicating that they felt they had insufficient information to comment, whilst a few other comments received once again indicated a concern about potential creation of drug related issues in the area.

#### **Q.9.** Please write any other comments you may have ?

Of those who provided additional comments it is reasonable to conclude that the consensus was the impact of the proposed application would be positive.

The final question (Q9) provided an opportunity for people to provide any other comments, and many took the opportunity to provide further comments. Most of the views expressed were favourable towards the application and reflected feed-back from young people with families, older people, and partially sighted residents. Their comments included positive impact on the community, negating the need to rely on public transport, and the need to allow for the future development currently underway in the surrounding areas. However, once again, there was concern expressed regarding the potential drug abuse and associated problems.

#### 5.2 Other written responses

One written letter of response was also received from Secretary of Myrtletown Park Residents Association, expressing concern about the provision of a methadone clinic/needle exchange near a primary school, nursery and Nursing Home. (Appendix 5).

#### 6. CONCLUSIONS

The challenge of a consultation is always to reach as many interested parties as possible, to give them the opportunity to state their views. A wide ranging approach was used including local media coverage and local mail drops. An approach was extended to Scottish Health Council for comments, however, to date no reply has been received.

Survey responses were received from 766 people.

In terms of the feed-back on the specific questions there was a strong

consensus across all elements of the consultation with the vast majority supporting the location, opening times and range of services as proposed.

On completion of this report Highland Pharmacy will then decide whether he wishes to submit an application or not under the Regulations to NHS Highland to open a pharmacy in Cradlehall.

#### Introduction

Under the National Health Service (Pharmaceutical Services) (Scotland) Regulations 2009 as amended, Highland Pharmacy intends to submit an application to be located at Cradlehall Court.

Before any application is made Highland Pharmacy and NHS Highland are required to undertake a joint consultation exercise. The purpose of the consultation is two-fold:

- to seek views of local people as to whether they feel they have adequate access to pharmacy services in the area,
- measure the level of local support for the potential new pharmacy in the area

The joint consultation must run for at least 90 working days from the start date of the advertisement.

The potential applicant will then have 90 days (not working days) from the end of the joint consultation (9<sup>th</sup> May) to submit their application to the Secretary to the Pharmacy Practices Committee, NHS Highland, Assynt House, Inverness. IV2 3BW

This document sets out the initial planned activities to underpin communications and engagement around the public consultation. It has been agreed by NHS Highland, Highland Pharmacy, the applicant and Scottish Health Council. The plan will be further developed as required to respond to any additional gaps or requests.


