CAPSASIN CREAM – Learning from incident

Message from Julie Stewart - Senior Clinical Pharmacist - Pain Management

NHS Ayrshire and Arran have recently received a complaint from a patient who was prescribed capsaicin cream 0.075% cream by a consultant and was told this was not available at the community pharmacy. We would like to remind all community pharmacies that unlicensed preparations for both strengths of Capsaicin cream are currently available and can be obtained via specials manufacturers following the usual specials authorisation process.

On completion, a certificate of participation can be requested; this will not be linked to your responses.

The objectives of the study are to:
