Salbutamol 2.5mg/2.5ml and 5mg/2.5ml nebuliser liquid unit dose vials Shortage- We have suspended the ULM Process for this item until June 2024, please see below for more detail.

Aclomep- The Use of Proton Pump Inhibitors in Neonates and Paediatrics guideline was published on the NHSL guideline site in October 2023. Aclomep (ULM Brand- ULM omeprazole liquid) is listed as a second line formulary choice for use in paediatrics. The choice of Aclomep brand in paediatric patients was decided by the paediatric pharmacists due to the viscosity and level of excipients having been deemed to be of a safe level in the paediatric patient population. We remind pharmacies to please order & dispense by BRAND Alcomep if a prescription requesting this brand is received for the clinical reasons cited. We also remind pharmacies of the need to add an electronic SPE when dispensing and endorsing Aclomep. For more information, please read Prescribing Notes October 2023 edition. Thank you.

SHORTAGES

Salbutamol 2.5mg/2.5ml and 5mg/2.5ml nebuliser liquid unit dose vials Shortage- Suspended ULM Process

To make it easier for pharmacies & patients, we have suspended the need to seek ULM authorisation for **Salbutamol 2.5mg/2.5ml and 5mg/2.5ml nebuliser liquid** until the end of June 2024, when we will review.

However we would ask you to feedback to us as soon as possible any significant issues you encounter when ordering these specials so we can help support and share information across the network.

The most current list of wholesaler supplies available has been circulated via clinical mailboxes to each pharmacy.

We ask you to please share this with your team and locums. We ask teams to engage in good local conversations with GP practices, prescribers and patients around your stock levels of this.

We ask you to check & be mindful of your stores stock levels of these, considering your regular patients who normally regularly order these, being mindful of the long lead times for ordering the specials recommended.

MAR Chart Service Community Pharmacy Lanarkshire- FAQs

What is the MAR Chart Service in Community Pharmacy in NHS Lanarkshire?

The MAR chart service (Medicines Administration Recording) asks community pharmacies to provide a clinically checked and up-to-date MAR chart for patients whom require medicines administration (Level C) from a Social Care service.

Who is eligible for a MAR Chart in this service?

Many patients who live at home may require additional support to manage their Activities of Daily Living, with support often provided by family members and other unpaid carers, Social Care services and Health services, or any combination of these.

Some people will require support with their prescribed medication as part of a Social Care package. For these people, an assessment of the level of medication support required will be undertaken by Social Care services in order to identify a level of medication support that matches the person's needs.

The MAR Chart Service supports patients who have had a social care service assessment, in which this assessment has indicated that these patients require a MAR chart to support medicines administration by a Social Care service as part of their social care package.

How will I know in my pharmacy a patient has had a social care assessment?

The request for a MAR chart will come from Social Care Services. If your unsure, please contact your local social care services department.

Payment for the Service

The agreed payment to any Lanarkshire Community Pharmacy providing this service is £5 per patient, per month. With an additional one-off service set-up fee of £100 also agreed. These fees relate to provision of a MAR chart service to a patient who will have their medication administered by a Social Care service.

Funding does not include patients in care homes (where payment is via LES agreement), or situations where a Social Care service does not administer the person's medication.
