## **IMPORTANT UPDATE – Antimicrobial Companion App**

As per previous communications, the Antimicrobial companion app which many of you (especially IP's) will use is closing at the end of March.

On Tuesday 26<sup>th</sup> March Ayrshire and Arran empirical guidelines moved to new host locations.

Adult (16yr+) guidelines have moved to the NHS Ayrshire & Arran Therapeutics Handbook. This can be downloaded as an app for smartphone. Instructions are below and user name/password details have been e-mailed separately this week to pharmacy clinical mailboxes.

## NHS Pharmacy First Scotland – PGD Updates

The updated PGD's for the Shingles and Bacterial Skin infection services have been issued this week. These CAN be used immediately however the service can continue to be provided from the previous PGD's until you are in a position to review and sign the updated ones.

# Fiasp® FlexTouch® Shortages

The letter below has been sent to all patients in Ayrshire & Arran prescribed the above product and you will see the prescriptions for the replacement items come through. The letter advises patients that they can speak to their community pharmacist for advice regarding the Novopen 6 device if they require support and we thank you in advance for providing guidance to patients if they require it.

Wording in patient letter is below:

Changes to your diabetic medication

You are currently prescribed Fiasp® FlexTouch® (insulin aspart) 100units/ml prefilled pens as part of your diabetic management.

From April 2024 until January 2025, Fiasp® FlexTouch® (insulin aspart) 100units/ml prefilled pens will be out of stock. However, Fiasp® Penfill® (insulin aspart) 100units/ml solution for injection 3ml cartridges will remain available.

Therefore, we have switched your prescription to Fiasp® 100units/ml Penfill® cartridges.

A prescription has been issued for cartridges alongside a Novopen 6 reusable device, which is used to administer insulin from the cartridges. An information sheet is enclosed which details how to use the Novopen 6 device with

your Fiasp® Penfill® cartridges. Should you require any further assistance in addition to this, please contact your community pharmacy or the pharmacy team within your GP practice, who will be able to support with this.

Your repeat medication list has been updated. If your pharmacy orders your repeat prescription for you, please inform them of this change to your medicines.

If you feel that your diabetes control is worse for any reason, please do not hesitate to contact the GP practice
