Public Health Update

[Aberdeenshire Period Poverty Update](#)

As you may be aware, Scotland was the first country in the world to offer the right to free period products. Aberdeen City and Moray pharmacies already have systems in place to stock free sanitary wear and now we're pleased to confirm that all pharmacies in Aberdeenshire can now follow suit.

Aberdeenshire Council, through Scottish Government funding, provides free access to disposable period products as well as re-usable alternatives. Products can already be accessed in many Aberdeenshire venues (e.g libraries, sports centres, community centres etc), all of which can be identified via the [PickUpMyPeriod](#) App. Further information can be found on the [Aberdeenshire Council](#) website.

Pharmacies and Health Centres in Aberdeenshire can now order stock by using this [Online Order Form](#) (once you accept the declaration, more questions will appear). Due to limited capacity within the service to handle orders, where a Pharmacy or Health Centre is unable to hold a large quantity of stock which results in future orders being small and frequent, they will be asked to collect products from one of our Distribution Hubs rather than use the online form. This will be monitored and discussed on an individual basis with each pharmacy or health centre where required.

Smoking Cessation Update

Smoking Cessation Quarter 3 (October - December 2023) Data Comparison with Quarter 3 2022

The table below shows the data for all pharmacies in Grampian. Overall there were higher sign ups than this time last year and a slightly lower rate of missed submissions at 4-weeks. Also on a positive note, more patients were retained to the 12 week mark. On a negative note, there's a higher number of missed 12-week submissions and successful quits have dropped substantially.

Please ensure every patient who is signed up to the programme also has 4-week data entered onto PCR even if they drop out (try to contact them 3 times) or have an unsuccessful quit.

Those who are successful at 4 weeks should have data entered at 12 weeks, again, even if they drop out or are unsuccessful. If they are not successful or have been lost to follow up, the case should be closed after your 4 week claim. If the patient wants to restart the programme, you can now open a new PCR case immediately, even if you haven't closed off the existing 4 week entry yet.

You are paid for the work you do, not whether the patient is successful or not.

If you miss a submission, we can help you claim back the money and amend the National Database for accuracy. We will need:

- Patient CHI and initials.
- Which submission you are claiming for (4 and/or 12 week).
- Whether the patient was successful or not, or lost to follow up.

We are unable to amend your PCR and therefore the quarterly data for your pharmacy will still mark them as "missed submissions". Please remember we are only here for the odd mistake and are NOT part of the system for claiming. If you are a pharmacy with high submissions, please check your housekeeping and create a more robust system.

Emails will be/have been sent to any pharmacy who had a higher than average missed submission rate and we will review this again in 3 months.
