The flu vaccination service has now gone live!

The PGD and corresponding MS form has been uploaded to the Community Pharmacy Website for reference.

**FAO Participating Pharmacies** 

Stock is ordered from Movianto via their online portal that you will have received details of. You will not receive an automatic allocation of stock.

Each participating pharmacy has a 'pot' of vaccine available to order. There are 2 packs of aQIV and 3 packs of QIVc available for each pharmacy initially.
