
What do you do to relax outside of work?

Levels of Care

Below is a useful grid reminder of the levels of care patients may have in place, and what they mean with regards to the administration of medicines. There appears to be some confusion occasionally as to what exactly each level of care corresponds to.

District Nurse/ Specialist Nurse input required. Beyond the skill of the Care Worker.

Education and Training: FTY Information Request

Trainee pharmacists starting their FTY from July 2025 will require both, a designated supervisor (DS) and a **designated prescribing practitioner (DPP)** during their PLP when the GPhC prescribing learning outcomes will be assessed. The DS may also be the DPP if appropriately qualified. We are keen to understand the current position of placements, supervisors and DPPs in Community Pharmacy. Keen for responses from all contractors even if if it's nil response.



National Unscheduled Care PGD

The updated (V31) unscheduled care PGD was distributed to community pharmacies this morning via e-mail.

As a reminder, NHS A&A based pharmacists should confirm signing of the PGD via following the <u>link</u> or by scanning QR code below. There is no need to send copies of signed documents to the health board but these should be stored in your pharmacy.
