- Over 360,000 NHS Pharmacy First Scotland consultations have taken place, this is 10% more than in 2023!
- Our award winning hospital discharge service also continues to support rapid discharge from the acute hospital sites and feedback received shows that your patients love this service and that pharmacy teams enjoy delivering this service.
- Vaccination activity has increased again this year and as well as the flu service we have COVID vaccinations being delivered from a community pharmacy on Arran to support the island population.
- Protected learning time for community pharmacy teams was introduced successfully and will be continued in 2025.

# This Weeks Key Messages

# Festive Pressures - Working together for the patient

It is the time of year where all services are under pressure due to demand on our healthcare system. Pharmacy is no different be that community, primary care or acute services.

Over the coming days there is likely to be an increase in patients being discharged from our hospitals as we support patient to be at home over the festive period and therefore inevitably more MDS patients being discharged.

Compliance aid patients leaving the acute sites on 18<sup>th</sup> and 19<sup>th</sup> December have been issued with double MDS packs to relieve pressure in the Christmas week for community pharmacies.

As a reminder, you will automatically receive notification when an MDS patient is admitted and an electronic copy of their immediate discharge letter (IDL) when they are discharged. This will give you details of when the patient was discharged allowing you to make any required changes before their next MDS is required.

Given the reduced working days over the festive period please communicate with the pharmacy teams in GP practices and use the resources / services you have available to help ease pressure and ensure patients get required medicines in time.

Electronic IDL's, Emergency Care Summary and GP practice pharmacy teams are all excellent sources of information and the unscheduled care service can be used in the absence of a prescription in many circumstances.

#### Liraglutide update

Diavic® (Liraglutide) is a now available for prescribing for the treatment of type 2 diabetes mellitus as an adjunct to diet and exercise. It is manufactured by Sun Pharma and can be ordered by Community Pharmacies exclusively via Alliance Healthcare.

This medication is not currently on the formulary but is expected to be added early next year. Prescriptions will be issued from GP practices for this medication. We have asked prescribers to write this as the brand (Diavic®) to ensure the correct product is given.

#### **Prostate Cancer Service**

A reminder to all pharmacies who participate in the prostate cancer service:

The SLA specifies that Enzalutamide stock should ONLY be purchased directly from the manufacturer, Astellas. While alliance healthcare are used to distribute the stock the orders from community pharmacies should be placed directly with Astellas. (Details in excerpt from the SLA below)

MEDICINE RESOURCING REQUIREMENTS

All orders must be placed with the manufacturer (Astellas) directly by telephone or email. Astellas Customer Service can be contacted on 0203 379 8721 or email ukcustomerservices@astellas.com.

If problems in accessing the medicine via this supply route cannot be resolved through direct dialogue with Astellas, contact the Health Board. Do not purchase from any other supply route without the approval of the Health Board.
