NES Pharmacy Webinar – Medication Assisted Treatment (MAT) Standards in Community Pharmacy

The webinar aims to raise awareness about the essential role of pharmacy teams in implementing MAT standards and the impact of trauma and stigma on outcomes for those with substance use disorder.

Speakers confirmed are:

- Catriona Matheson, Professor of Substance Use, University of Stirling who will provide insights into the current landscape of Drug Related Deaths (DRDs) in Scotland
- Adrian Mackenzie, Clinical Lead, MAT Standards, healthcare Improvement Scotland will explain the MAT Standards and their significance to pharmacy teams.
- **Jonathan Burton,** Scottish Pharmacy Board, RPS and Community pharmacist will talk about Positive Pharmacy experiences and the impact of stigma.
- An additional speaker who will focus on Positive Pharmacy experiences focusing on the impact of trauma

The evening will also launch updated resources related to Substance Use and ensure teams are aware of other resources to the support the recovery journey of people who use substances.

We would encourage community pharmacy teams to register for this event, particularly those providing substance use services or with an interest in this area.

Novorapid Flextouch Update

As of the end of March 2025, Novorapid Flextouch® will be discontinued. Patients prescribed this will be switched to Novorapid Flexpen® device which works in a similar way.

Discontinuation of Freestyle Libre 2 – a reminder

As per previous communications, Freestyle Libre 2 will be discontinued at the end of March 2025 and replaced with Freestyle Libre 2+. Therefore, Freestyle Libre 2+ has been added to the NHS Ayrshire & Arran Formulary as a replacement. As a result, all new patients will be commenced on Freestyle Libre 2+. All existing patients prescribed Freestyle Libre 2 will be switched to Freestyle Libre 2+ between January and March 2025. Please continue to be mindful of Freestyle Libre 2 stock levels ahead of this change.

Pharmacotherapy teams within surgeries will begin actioning this change imminently with teams lettering patients to advise patients. As with any change of this kind, patients may attend their local Community Pharmacy seeking clarification of this change, the support of the CP network is appreciated.
