ACTION REQUIRED: HRT Unopposed Oestrogens Project

All community pharmacies should have received the HRT Unopposed Oestrogen patient information cards by 16th January 2026.

Pharmacy teams were asked to watch the video on HRT and engage in conversations with patients who fall into this category, using the patient safety cards to aid patient discussions. This should help to provide enhanced support for patients, highlighting the importance of taking progestogen alongside oestrogen HRT – where clinically indicated – to reduce the risk of endometrial hyperplasia and its potential progression to endometrial cancer.

Seeking Community Pharmacy Representation – Transitions of Care for Care Home Residents Improvement Group

INFORMATION: Rybelsus Switch

A new formulation of Rybelsus tablets has been launched in the UK.

The new formulation has a higher bioavailability (higher amount of the active drug absorbed into the blood stream) compared with the initial formulation, meaning that smaller doses achieve the same effect. At present, both formulations are temporarily available meaning there is a risk of patients being prescribed an incorrect dose, which could result in potential overdose and increased risk of gastrointestinal side effects. **Distribution of Rybelsus 3mg, 7mg and 14mg tablets will stop from 31st January 2026.**

Smoking Cessation

Cessation Corner #22

What are tobacco pouches?

They are for oral use only and are small, white pouches placed between the gum and lip. They release nicotine into the mouth without producing smoke. They come in two types:

Nicotine pouches (tobacco-free)

- Contain nicotine, flavourings, and plant fibres
- Do **not** contain tobacco leaf
- Brands include ZYN, Velo, Nordic Spirit, etc.
- Often marketed as "smoke-free" or "discreet"
- Come in a variety of strengths


Tobacco pouches (with actual tobacco)

- Contain finely ground tobacco
- Like traditional Swedish snus, but products vary by region. **Illegal to sell in the UK.**
- Still deliver nicotine and tobacco-specific chemicals

Unlike tobacco products and e-cigarettes, there are currently **NO** regulations in place for nicotine pouches. The government plans to introduce age restrictions and tighter regulations for these under the Tobacco and Vapes Bill to stop sales to children.

USE: Currently 1% of adults are thoughts to use or have used nicotine pouches, mainly to help them stop smoking. The number using nicotine pouches is on the rise especially in males 16-24 years. Only 84% were previous smokers or vapers.

Most nicotine pouches are manufactured by tobacco companies. They are currently moving away from combustible tobacco and moving into nicotine-only or heat-not-burn products in the hope of retaining consumers and making huge profits. They are currently using the same marketing and advertising methods that we previously saw them use with tobacco. Zyn is made by Philip Morris International who produce Marlboro cigarettes. Velo is made by British American Tobacco who produce Lucky Strike cigarettes. Nordic Spirit is made by a Swedish Snus company.



These products should NOT be sold as Nicotine Replacement Therapy (NRT)

Nicotine pouches sold in the UK are regulated under the Tobacco and Related Products Regulations (TRPR) 2016 and are **not classified as medicines**.

Because they are not medicines, they cannot make therapeutic (quit-smoking) claims and therefore cannot be marketed or described as Nicotine Replacement Therapy (NRT). To be called NRT, the product must meet medicine-level standards of quality, safety, and efficacy and obtain a marketing authorisation.

Nicotine pouches should NEVER be located next to legitimate NRT products in your pharmacy. Doing so sends the message that they are legal medicines for smoking cessation when they are not.
