ACTION	Fraudulent Private Prescriptions for Codeine Linctus		
	<p>There have been recent reports in England of fraudulent private prescriptions being presented for Codeine Linctus. Please remain vigilant for suspected fraudulent private prescriptions for this and other medicines with abuse potential.</p> <p>We would be grateful if you could highlight to us if any prescriptions of this nature are presented to you.</p> <p>As with all private prescriptions (or any prescription for that matter) we would ask that all due diligence is given to ensuring the prescriber details and the authenticity of any prescription are checked before a professional and clinical decision is made as to whether supply is appropriate. This may include checking that a private prescriber is appropriately registered and consider contacting the issuing clinic directly to confirm that a prescription is genuine. Important Information- This week it is feeding tube feeding awareness week. #FeedingTubeAwarenessWeek

Tube feeding is required when a patient is unable to meet their nutritional requirements orally therefore have had a tube inserted either via their nose, stomach or jejunum. Patients in NHSGGC who are fed via this method are registered with the contracted company Nutricia who then supply and deliver their feed and ancillaries directly to their door. Community pharmacies should never be requested to dispense tube feed products which generally come in 500,1000 or 1500ml containers. Some community pharmacies have dispensed these products in the past year which would have been done in good faith but should not be happening.

Action required by community pharmacies.

- If you receive a prescription for these products in the future please return this to the GP ASAP as it has probably been sent in error. These prescriptions require to be sent by the GP to Nutricia

in England on a monthly basis to allow the timely delivery of the products required by the patients.

<p>   MCR_Registration_Training_Guid.docx  <b>Attached</b> </p>	<p>I wanted to take a moment to thank everyone for your ongoing dedication and for reaching out with questions regarding the stage 1 medication reviews. Your commitment to delivering excellent service is greatly appreciated, and together we can ensure a smooth and consistent MCR registration process for our patients.</p> <p>To clarify the procedure and support you further, here are the essential steps for registering a patient for MCR and ensuring the review counts towards your payment from the MCR dispensing pool:</p> <ul style="list-style-type: none"> <li>- Any patient is eligible for a stage 1 medication review, but to be included in the MCR dispensing pool, the patient must be registered for MCR.</li> <li>- Before registration, please always seek the patient’s consent to participate in the service.</li> <li>- Where possible, obtain the patient’s signature on the registration form, as this helps prevent any anomalies being flagged at NSS.</li> <li>- Register the patient in the PMR system following the attached guide, which outlines each step in detail.</li> </ul>

For your reference, I have attached a guide that explains the MCR registration process, including helpful definitions for technical terms such as MCR (Medicines: Care and Review), SRx (Serial Prescription), and PMR (Patient Medication Record), which may be useful for newer team members.

**Pre-Reg Pharmacy Technician**

Due to the increasing workforce pressures, particularly the impact of the emerging GP Practice Pharmacotherapy Services, NHS GGC has plans to increase the number of pharmacy technicians working in GP practices and in order to do this we plan to recruit and train pre-

registration pharmacy technicians that will be employed on a two year fixed contract by the HSCPs.

Community pharmacy has a very key role to play in the delivery of pharmacotherapy services and we would like to strengthen the already established links between community pharmacies and their local GP practices.

Within GGC we will be recruiting **three** pre-registration pharmacy technician who we expect, following a 2 year pre-registration training course, to be GPhC registered by 2028.

We are keen that these pre-registration pharmacy technicians have experiential learning delivered in more than one sector of pharmacy, in-fact it is not possible to obtain the required competencies for GPhC registration wholly in primary care. Our model is that the pre-registration pharmacy technician works 2 days per week in a local community pharmacy and 2 days per week in a local GP practice/Hub setting. Day 5 is spent on undertaking college learning/assessments.

At this stage we are aiming to establish any interest from community pharmacies who would be able to provide up to 24 months of experiential learning for a pre-registration pharmacy technician.

In this April 2026 cohort we have a post within each of these HSCPs **Glasgow North West HSCP, Glasgow North East HSCP and Renfrewshire HSCPs**

We had an overwhelming response and it's so encouraging to see the engagement from community pharmacies to test and participate in new services. Unfortunately, as you know, there was only funding available to test in six sites. For transparency, site selection was made on the following criteria:

Screening criteria from the checklist

Digipharma vs non-Digipharma users

Overall availability of a CPIP (to increase likelihood that 50 tests could be undertaken in the timeframe)

Prescribing data

Spread across HSCP areas

This resulted in >6 sites meeting criteria. To ensure fairness and equity, the sites were allocated a number and entered into a random number generator.

The six successful sites have been informed.

Important Information- This week it is feeding tube feeding awareness week. #FeedingTubeAwarenessWeek

Tube feeding is required when a patient is unable to meet their nutritional requirements orally therefore have had a tube inserted either via their nose, stomach or jejunum. Patients in NHSGGC who are fed via this method are registered with the contracted company Nutricia who then supply and deliver their feed and ancillaries directly to their door.

Community pharmacies should never be requested to dispense tube feed products which generally come in 500,1000 or 1500ml containers. Some community pharmacies have dispensed these products in the past year which would have been done in good faith but should not be happening.

Action required by community pharmacies.

- If you receive a prescription for these products in the future please return this to the GP ASAP as it has probably been sent in error. These prescriptions require to be sent by the GP to Nutricia in England on a monthly basis to allow the timely delivery of the products required by the patients.

	<p>It has been brought to our attention by our Dietetic colleagues that a number of issues have recently occurred with CPNSS prescriptions. As there has been a recent formulary change and an updated communication has already been shared, we would like to provide a brief reminder to support safe and accurate prescribing. Below are examples of issues identified:</p> <hr/> <p><b>Incorrect ONS Products Supplied</b></p> <p>Several patients have received the wrong product, resulting in inappropriate nutritional intake:</p> <ul style="list-style-type: none"><li>• <b>Altraplen Compact Daily (250ml) x2/day</b> supplied <b>instead of Altraplen Energy (200ml) x2/day</b> → This resulted in the patient receiving <b>double the intended calories and protein</b>, causing tolerance issues.</li><li>• <b>Altraplen Compact (125ml) x1/day</b> supplied <b>instead of Altraplen Compact Daily (250ml) x1/day</b> → This provided only <b>half of the prescribed volume</b>, preventing the patient from meeting the nutritional goals agreed with the Dietitian. → Please also note: <b>Altraplen Compact (125ml)</b> is <b>non-formulary</b> within NHSGGC.</li></ul> <hr/> <p><b>GP10 Issued When CPNSS Was Active</b></p> <p>If a patient is known to be on CPNSS and a GP10 request is received, please <b>do not issue</b> the GP10 without first contacting the Dietetic Team who originally submitted the CPNSS paperwork. This prevents duplication, incorrect product supply, and confusion for the patient.</p> <hr/> <p><b>Mailbox Monitoring</b></p> <p>Please ensure clinical mailboxes are <b>checked daily</b> for CPNSS ONS request forms. Once received, these requests should be <b>actioned as soon as possible</b> so that patients receive the correct product in a timely manner.</p> <hr/> <p>Thank you for your cooperation and continued support in ensuring safe and effective patient care. Important Information- This week it is feeding tube feeding awareness week. #FeedingTubeAwarenessWeek

Tube feeding is required when a patient is unable to meet their nutritional requirements orally therefore have had a tube inserted either via their nose, stomach or jejunum. Patients in NHSGGC who are fed via this method are registered with the contracted company Nutricia who then supply and deliver their feed and ancillaries directly to their door.

Community pharmacies should never be requested to dispense tube feed products which generally come in 500,1000 or 1500ml containers. Some community pharmacies have dispensed these products in the past year which would have been done in good faith but should not be happening.

Action required by community pharmacies.

- If you receive a prescription for these products in the future please return this to the GP ASAP as it has probably been sent in error. These prescriptions require to be sent by the GP to Nutricia in England on a monthly basis to allow the timely delivery of the products required by the patients.

<b>IMPORTANT INFORMATION</b>	<b>Important Reminder – CPNSS Prescription Accuracy and Required Actions</b>
	<p>It has been brought to our attention by our Dietetic colleagues that a number of issues have recently occurred with CPNSS prescriptions. As there has been a recent formulary change and an updated communication has already been shared, we would like to provide a brief reminder to support safe and accurate prescribing. Below are examples of issues identified:</p> <hr/> <p><b>Incorrect ONS Products Supplied</b></p> <p>Several patients have received the wrong product, resulting in inappropriate nutritional intake:</p> <ul style="list-style-type: none"><li>• <b>Altraplen Compact Daily (250ml) x2/day supplied instead of Altraplen Energy (200ml) x2/day</b></li></ul>

→ This resulted in the patient receiving **double the intended calories and protein**, causing tolerance issues.

- **Altraplen Compact (125ml) x1/day** supplied instead of **Altraplen Compact Daily (250ml) x1/day**

→ This provided only **half of the prescribed volume**, preventing the patient from meeting the nutritional goals agreed with the Dietitian.

→ Please also note: **Altraplen Compact (125ml)** is **non-formulary** within NHSGGC.

### **GP10 Issued When CPNSS Was Active**

If a patient is known to be on CPNSS and a GP10 request is received, please **do not issue** the GP10 without first contacting the Dietetic Team who originally submitted the CPNSS paperwork. This prevents duplication, incorrect product supply, and confusion for the patient.

---

### **Mailbox Monitoring**

Please ensure clinical mailboxes are **checked daily** for CPNSS ONS request forms. Once received, these requests should be **actioned as soon as possible** so that patients receive the correct product in a timely manner.

**Sore Throat Pilot**

Thank you for your interest in testing the Sore Throat Strep A POC pilot. We had an overwhelming response and it's so encouraging to see the engagement from community pharmacies to test and participate in new services. Unfortunately, as you know, there was only funding available to test in six sites. For transparency, site selection was made on the following criteria:

Screening criteria from the checklist

Digipharma vs non-Digipharma users

Overall availability of a CPIP (to increase likelihood that 50 tests could be undertaken in the timeframe)

Prescribing data

Spread across HSCP areas

This resulted in >6 sites meeting criteria. To ensure fairness and equity, the sites were allocated a number and entered into a random number generator.

The six successful sites have been informed.
