| | <p>DHSC has advised of a Tier 3 supply issue affecting Diamorphine 5 mg, 10 mg and 100 mg powder for solution for injection ampoules.</p> <p>Please see the attached MSN and summary below.</p> <p>Summary</p> |

- Diamorphine 5 mg and 10 mg powder for solution for injection ampoules are currently out of stock, with no confirmed resupply date.
- Diamorphine 100 mg powder for solution for injection ampoules are expected to become unavailable from early January, with no confirmed resupply date.
- Diamorphine 30 mg powder for solution for injection ampoules are currently available, but are unable to support any increase in demand.
- Morphine sulfate injection has been identified by clinical experts as the first-line alternative opioid.
- Sufficient supplies of morphine sulfate 10 mg/ml injection are available from Ethypharm and Hameln to cover the supply gap.
- During previous shortages of diamorphine, both primary and secondary care organisations were advised to switch to morphine, where clinically appropriate. This should be expedited as a permanent change in practice given the continuing unpredictable supply of diamorphine.
