IMPORTANT INFORMATION	Business Continuity Plan
	<p>As you will be aware contingency planning for a range of risks is a key business activity to ensure essential services continue to be provided and maintained in an emergency situation.</p> <p>Every year we provide an annual reminder to community pharmacies that they should have an up to date Business Continuity Plan (BCP), the content of which should be relevant and reflect events such as adverse weather.</p> <p>All contractors should review their plan over the next four to six weeks to ensure it remains “fit for purpose” and contains the most up to date information. There is no need for you to send a copy to the Board as previously. We would recommend however that a copy be retained “off-site” in the event that you are unable to access the pharmacy for any reason. You can access a blank BCP template from the Community Pharmacy website. 	<p>From time to time a situation arises where a medicine is available but is only available at a higher cost than the pharmacy will currently be reimbursed.
