Online Ordering Opening

- Sites Not Listed in Appendix A attached - The Movianto online ordering system, Marketplace, will be live and ready for you to order your first delivery of vaccines for the 2025/26 season on Tuesday 26th August from 9am. You can access Marketplace by clicking on this link: <https://marketplace.movianto.com>.
- Vaccine Holding Centres (VHC's) Listed in Appendix A attached - Order detail has already been provided to NP for the first 2 weeks of the campaign. See Appendix A for delivery dates. Please be advised your delivery arrangements will revert back to the standard delivery schedule Appendix B, from Mon 8th Sept (orders can be placed on Movianto Marketplace from w/c 2nd Sept for delivery w/c 8th Sept).

Please ensure orders are raised prior to 11.55am on your order cut-off day to ensure delivery is made on your scheduled delivery day.

Log-in details

Your log-in details will be the same as those issued to you last year. If you need to reset your password, please click on the "Forgot Password?" link on the Marketplace log-in screen and follow the instructions on screen.

Any staff who have been set up with access to Marketplace for the first time this season will have recently received an email containing log-in details. If you believe you should have received details but have not been sent an email please check your junk mail folder, otherwise please contact Movianto using the details below.

Placing your order

Available vaccines

Vaccine allocations

Allocations have been set by your health board and will be shared with you by your health board. If you have any queries relating to the allocation set for you, please contact your health board directly.

When placing orders in Marketplace any order which exceeds the allocation set for your site will not be processed. Please only order what has been allocated to you; this will help avoid any delays.

Searching for vaccines in Marketplace

When placing orders for the vaccines in Marketplace, practices should search for the type of vaccine required. For example, if vaccines are required for persons aged 18 to 64, and children aged 2-17 who cannot receive the nasal spray vaccine, these can be found in Marketplace by entering the search term "TIVc" on the 'Orders' screen. Similarly, the vaccines for patients aged 65 and over can be found by searching for "aTIV".

Ordering the correct quantity

Vaccines are available in packs of 10. On the ordering platform, please read the vaccine information carefully and order the number of packs required, not the number of doses. For example, if the practice wants to request a delivery of 500 vaccines an order should be placed for 50 packs of 10.

Patient Information Leaflets

Patient Information Leaflets for aTIV and TIVc will be automatically added to your vaccine orders. The leaflets will be supplied in pads of 10 leaflets with one pad supplied per pack of vaccine.

Egg-free vaccine

The cell-based quadrivalent vaccine (TIVc) does not contain egg.

Vaccines for children who cannot receive the nasal spray vaccine

Infants aged from 6 months to 2 years can be offered TIVc.

Children 2 years and older can also be offered TIVc.
