



# Seasonal Flu Vaccination

## Eligibility for winter 2025/26

As per the 2025 Adult & Child Flu CMO letter, people in the following groups will be offered **flu vaccination only**:

- aged 65 and over
- aged 18 to 64 with an eligible health condition
- Pregnant
- living in a long-stay residential care home or other long-stay care facility
- working in a care home for older adults
- living with someone who has a weakened immune system
- an unpaid or young carer
- a frontline health or social care worker
- a non-frontline NHS worker
- a poultry worker or bird handler
- an asylum seeker living in a home office hotel or B&B accommodation
- experiencing homelessness or substance misuse
- living in a Scottish prison

# Delivery Methods

Our aim is to have a range of delivery methods available to ensure there are as few barriers as possible to those who wish vaccination being able to access it;

- Childhood Programme
  - Separate clinics are arranged for preschool children
  - Primary and secondary school children are offered vaccination at school and mop up clinics are planned should a child be off school
- Adult Flu and All Covid
  - Our community clinics will continue in partnership with our six Local Authorities and HSCPs. These will be in 20 separate venues. This will be supplemented by a mobile vaccination service operated by the Scottish Ambulance Service. Those unable to attend a clinic will be seen at home by their local HCSP. HCSPs will also deliver vaccination in care homes and those who are housebound.
  - NHS staff are also able to act as peer immunisers for the flu vaccine and are currently awaiting final figures.

# Community Pharmacy Delivery Model

Community Pharmacy is expected to vaccinate:

- aged 65 and over
- aged 18 to 64 with an eligible health condition
- working in a care home for older adults
- living with someone who has a weakened immune system
- an unpaid or young carer
- a frontline health or social care worker
- a non-frontline NHS worker
- a poultry worker or bird handler
- an asylum seeker living in a home office hotel or B&B accommodation
- experiencing homelessness or substance misuse

# SLA Competencies

- The Pharmacy Contractor must ensure that all Pharmacists and registered Pharmacy Technicians (where the Protocol has been adopted) providing the service are competent to do so and have completed the necessary training.
- Pharmacists and registered Pharmacy Technicians (where the Protocol has been adopted) should demonstrate to the Pharmacy Contractor that they have the necessary knowledge and skills to provide the service.
- 6.2 The Pharmacy Contractor must ensure that Pharmacists and registered Pharmacy Technicians (where the Protocol has been adopted) providing the service are aware of the National Minimum Standards in relation to vaccination training, and are compliant with the training requirements within those Standards that apply to Pharmacists and registered Technicians
- 5.12 The Pharmacy Contractor is required to record and report any patient safety incidents to NHS GGC Public Health Protection Unit on 0141 201 4917 on [PharmacyPublicHealth@ggc.scot.nhs.uk](mailto:PharmacyPublicHealth@ggc.scot.nhs.uk)
- 5.13 The Pharmacy Contractor will ensure that the Key Pharmacist completes NHS GGC's Cold Chain Audit preferably before the flu season starts but certainly before the end of the season. Failure to complete the module will result in a financial penalty (Para 12.).
- 9 | Page Pharmacy Technicians providing the service. Pharmacists and registered Pharmacy Technicians (where the Protocol has been adopted) providing the service should undertake face-to-face training for injection technique and basic life support (including administration of adrenaline for anaphylaxis in line with National Standards).

## Delivery Schedule

For the period Monday 2 September to Friday 20 September sites will have set delivery days: this is to help ease order congestion and manage capacity during the busy initial stage of the programme. Sites should refer to Appendix A for details of their ordering day during this period. If a site requires a second delivery in the same week, please contact [nss.vaccinenquiries@nhs.scot](mailto:nss.vaccinenquiries@nhs.scot) with order details to arrange.

From Monday 23 September onwards a new delivery schedule will apply. Please refer to Appendix B for details for your site.

  - **Note:** Like last season, *vaccines have been allocated to each practice so you will therefore only have access to this volume of product. Allocation queries should be raised with Movianto.*



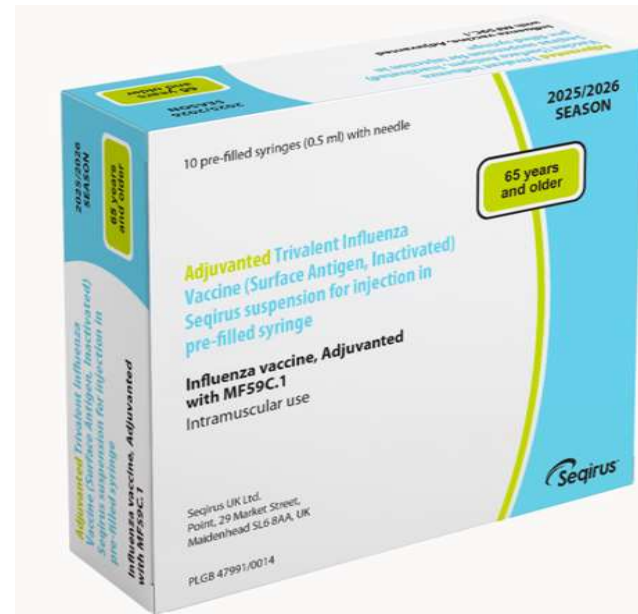

# Flu vaccines recommended 2025/26



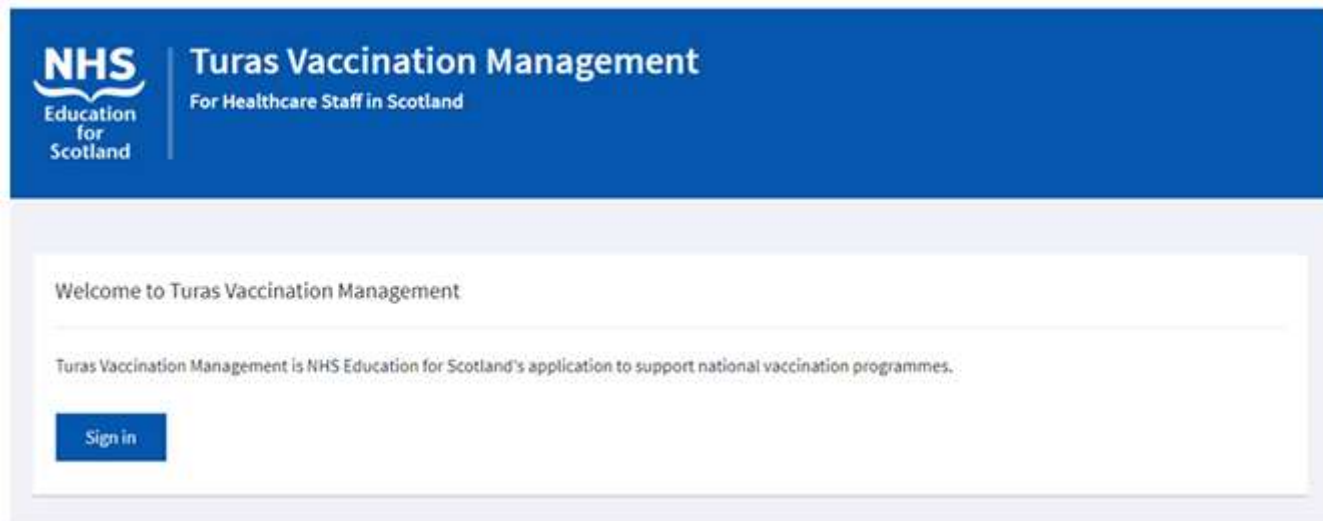
- In line with last year's arrangements, there are two vaccines available - aTIV (Seqirus) for individuals aged 65+ and TIVc (Seqirus) for all eligible individuals aged 64 and under.

# Vaccine Recording

- The VMT (Vaccine Management Tool) will be used to record flu vaccination.
- Flu data will be available in real time.



# Vaccine Recording Cont.

Things you can do to help:

- Ensure checked in at correct clinic
  - Ensure incomplete records are checked at the end of each clinic
  - Use a CHI Number wherever possible – request ID for spelling/DOB to register
  - Take time to register correct vaccination
