Quetiapine Immediate Release Tablets - Limited Supplies

Please find attached information pertaining to the ongoing supply challenges with several strengths (150mg, 200mg & 300mg) quetiapine immediate release tablets. These medications are in limited supply, therefore stock availabilities may change regularly as wholesalers continue to receive limited stocks.

Smoking Cessation

Suzanne and Denise are currently out and about visiting all pharmacies opportunistically. These visits are intended to be supportive and address any issues you have with your smoking cessation services. Cytisine

We have had some asks about Cytisine. The current information we have is listed below:

- Cytisine was licensed in the UK by the Medicines and Healthcare products Regulatory Agency (MHRA) in March 2019; however, supplies only became available in the UK in January 2024.
- Cytisine has not been considered by the Scottish Medicines Consortium (SMC) and is not currently included in the Grampian Formulary for smoking cessation.
- The Grampian Formulary Group has not received any request from any local clinician to add cytisine to the local formulary.
 - The Grampian Formulary Group has a long established process for managing the addition of medicines to the Grampian Formulary at the request of local clinicians. This process allows clinicians to request the addition of medicines that they consider have a strong evidence base and where there is a local desire to make the medicine available clinically.
 - If a request, for the addition of cytisine to the formulary, was to be received from a local clinician it would likely take four to five months for such an application to be processed; priority is given to SMC approved medicines in order to meet Scottish Government timelines for the introduction of SMC guidance.
