Wholesalers and Medicines Availability

We are aware that a number of manufacturers are using single wholesaler distribution models, meaning certain branded medications are only available via specific wholesalers e.g. Alliance or Phoenix. Whilst recognising that this add complexity and potentially additional costs for contractors, we write to remind all pharmacy contractors of the NHS Pharmaceutical Services (Scotland) Regulations (delivery of which is the essence of your Contract with NHS Grampian) requirement regarding the timely supply of medication in response to a prescription.

This means that if a patient presents a prescription in your pharmacy for an item supplied by a wholesaler which you do not use, you are required to do one of the following:

- a) Set up an account with that wholesaler to enable supply of the required medication OR
- b) Source another pharmacy who does have an account and can fulfil the prescription by the next working day for the patient.

Failure to provide a timely supply of medication in response to a prescription, where no mitigation in the form of a recognised shortage is present, will be considered a breach of your contractual obligation and will be escalated to NHS Grampian Pharmacy Performance and Governance Group.

Out of Stock Medicines Procedure

Where there is a genuine medicine shortage and you cannot fulfil the requested prescription, the following actions should be taken:

- a) Check all available wholesalers
- b) Check supplies with all other pharmacies in your network
- c) Review the unavailable medication information / MSAN on SPS: <u>Medicines supply SPS Specialist</u> Pharmacy Service The first stop for professional medicines advice
- d) Prepare a list of available alternative(s) to share with the patient's practice (please share this with colleagues if e.g. pharmacy dispenser phoning practice to report the shortage)
- e) Contact the practice and provide this alternative information. If there is uncertainty about the indication for treatment and the patient isn't available to confirm this, please discuss with the prescribing clinician.

If you receive a repeat or serial prescription for a known unavailable product, please do not wait until the patient attends for collection before you action this.

Finally, practice teams are generally in touch with each other and with multiple pharmacies; they also have the ability to look at shortage lists and contact wholesalers. Misinforming practices that a supply is not available when in fact it is available but not at the price below the tariff is likely to lead to a complain about failure to deliver contractual obligations. Likewise, patients are increasingly vocal about pharmacies failing to provide certain medicines when they are freely available from other pharmacies. We have seen an increase in complaints regarding these issues and the actions of the few do have the potential to bring the whole contractor network's reputation into question.

The Drug Tariff

All pharmacy contractors are reminded that failure to fulfil a prescription due to the product being above Tariff price is considered a clear breach of your contract. The reimbursement system for community pharmacies is based 'in the round' i.e. not all drugs will return the same margin for contractors and there are specific mechanisms in place to manage situations where the tariff is out of step with the market. Pharmacy contractors must not 'cherry pick' the prescriptions they supply based on the profitability of the supply. Using intermediate buying systems to filter out medications from your order lines based on purchase costs being above tariff is not acceptable.

The PCS regulations only allow refusal to supply under two circumstances; the first is suspicion of a fraudulent prescription (i.e. is not valid) and the second is where the supplying pharmacy has concerns over safety. Where the Board is aware of these measures being implemented by contractors, we will escalate and manage these concerns accordingly. If a professional or premises standard has been breached, this may also include a GPhC referral.

Methylphenidate MR Tablet Shortage

We continue to experience supply disruption across all brands of methylphenidate modified release tablets.

Please find attached a brief update to support with the management of patients who are unable to obtain their prescribed brand of methylphenidate modified release tablets.

Quetiapine Serious Shortage Protocols

To support with the management of ongoing quetiapine shortages the Scottish Government have issued a number of Serious Shortage Protocols (SSPs) for 150mg, 200mg, and 300mg immediate release quetiapine tablets.

Pharmacies are ask to read and adhere to the information within the SSPs to ensure the appropriate management of stocks for the duration of supply issues.

For each strength there are three SSPs:

- 1. **Substitution** with an alternative strength where the duration of treatment on the prescription is for one month's supply or less and prescribed product **is not** available
- 2. **Restriction** in quantity to supply where the duration of treatment on the prescription is for more **than** one month's supply and prescribed product is available.
- 3. **Substitution & restriction** in quantity to supply here the duration of treatment on the prescription is for more than one month's supply and prescribed product **is not** available.
