Shortage of Pancreatic Enzyme Replacement Therapy (PERT): Patient and Stock Management Update

The attached document is an update to information circulated on 4th July. This document is intended for use by Primary Care and Community Pharmacy teams to support with the ongoing management of PERT shortages. Secondary care colleagues are covering PERT patients who are seen regularly within their services (cystic fibrosis, pancreatic cancer) and sending contact clinical notes to practices to provide further advice when appropriate.

Supply Constraint of Creon (Pancreatin)

To try to ensure that there is a broad distribution of all Creon® strengths across UK pharmacies, we have agreed to place quotas on the number of packs each individual pharmacy can order. For more information on the quotas in place, please speak with your wholesaler to discuss this.

If the quotas are below your regular monthly usage, please let your wholesaler know. Full document attached.

Patient Safety: Removal of Epimax Products from the Grampian Area Formulary

MHRA Guidance - Dispensing Valproate Products

Please click <u>here</u> for the updated guidance from the MHRA on the dispensing of Valproate-containing products. We would encourage pharmacy teams to read and understand this guidance – which effectively mandates original pack dispensing of these products, with a few exceptions which can be made following assessment on a patient-patient basis.

Please note under 'Exceptional circumstances'

The manufacturer's original full pack does not have to be supplied where:

- (i) A risk assessment is in place that refers to the need for the patient to be sold or supplied valproate-containing medicines in different packaging from its manufacturer's original full outer packaging (for example, in a monitored dosage system) and
- (ii) Assuming that the product is authorised, there are processes in place to make sure that the patient receives the Patient Information Leaflet. That is not the case for unauthorised medicines, unless they are only unauthorised as a result of an assembly process.

NHS Grampian have produced a 'Health and Safety Risk Assessment,' that can be used in these exceptional circumstances. Please find attached 2 documents, which you can download and use.

'Assessment for Exception to Requirement to Dispense Sodium Valproate Containing Medicines in Original Packs – Community Pharmacies'

And

'HEALTH AND SAFETY RISK ASSESSMENT'

This assessment should be done by an appropriate healthcare professional prior to dispensing the prescription. The outcome of the risk assessment should be documented clearly in the patient's record, and a copy of the assessment stored securely.

Note: It is advisable to review and update the risk assessment periodically (for example, there are changes in the patient's circumstances). Advise patients to proactively inform the pharmacy if their circumstances change.
