Controlled Drug Prescription Duration of Opioid Replacement Therapies (ORT) Treatment Over 30 Days

Please find the attached letter for all Substance Use Service staff.

In some areas of NHS Grampian, Opioid Replacement Therapy (ORT) prescriptions are still being issued for much longer than 30 days. While this practice was accepted during COVID when additional restrictions were in place, this is no longer the case and we should be following best practice unless there is a justifiable clinical need for a longer prescription. Although this is good practice, it is not a legal requirement.

If you are presented with a prescription for longer than 30 days and you have any concerns, please discuss with the prescriber in the first instance to ensure patient treatment is not interrupted if they have a valid legal prescription.
