#### **Prostate Cancer Update**

As you will now be aware the Prostate Cancer Service Level Agreement has now ceased following Contractor Committee withdrawal. NHS Grampian has now moved to an alternative model of supply to collection hubs located across Grampian.

As medication aligned to this service is considered high cost we are asking contactors who have any remaining stock to contact the PCS team who may seek arrangements to collect and use at one of our collection hubs.

We can only accept unopened Xtandi stock which has been ordered by a UK Supplier Astellas. If you have opened stock or unused stock ordered through another supplier please dispose per waste procedures.

#### SUS Guidance Update

The supporting guidance for the Substance Use Service SLA has been updated and is attached, a copy can also be found on the community pharmacy website. It is important that both pharmacists and their teams involved in delivering the service read the document as there have been some important changes – such as an amended missed doses section, updates on new treatments (buvidal), as well as changes to the forms used to deliver the service. It also notes training to be completed by teams.

We do not expect teams to replace existing patient documents with the new forms but would ask that you use the new templates going forward. This guidance not only supports the contractual obligations for delivering the service, but has a host of useful information for both teams and patients.

#### **Mpox Update**

The UK does not currently recommend pre-travel vaccination for mpox. The JCVI continues to review latest data on the current Clade 1 mpox outbreak and will continue to update vaccination recommendations accordingly.

Consequently, the mpox related content on the PHS travel websites (TRAVAX and fitfortravel), and NHS Inform have been updated to align with related guidance from UKHSA and NaTHNaC (<u>Travel Health Prowebsite</u>).

### Valproate Use in Men

A retrospective observational study has indicated a possible association between valproate use by men around the time of conception and an increased risk of neurodevelopmental disorders in their children. Inform male patients who may father children of this possible increased risk and the recommendation to use effective contraception during valproate treatment and for at least 3 months after stopping valproate.

The diabetes supported self-management psychology service offers support for people with a new diagnosis of Type 2 Diabetes (<6 years), Prediabetes and Gestational Diabetes, who are struggling with their efforts to self-manage their condition.
