# **NHS Grampian Continuous Glucose Monitor Position Statement Update**

Please find linked an updated Position Statement relating to the use of Continuous Glucose Monitors (CGM's) within NHS Grampian - CGM Prescribing in Primary Care - Position Statement

### Important points to note for community pharmacies:

- Abbott have advised that the production of FreeStyle Libre® 2 sensors will cease, with stocks expected
  to be exhausted by June 2025.
- The diabetes specialist service and primary care will be working to switch patients to prescribing of FreeStyle Libre® 2 Plus sensors in the coming months.
- While the new 2 Plus sensors work in the same way and with the same apps, they differ in their duration
  of wear with FreeStyle Libre<sup>®</sup> 2 Plus sensors being worn for 15 days (versus 14 days with FreeStyle
  Libre<sup>®</sup> 2).

### **Actions for community pharmacies:**

- Where a patient has been switched to the 2 Plus sensors, ensure patients/carers are made aware of the change in days usage from 14 to 15 days.
- Be alert to the similarities of packaging of the Libre 2 and Libre2 Plus packing see images below (this has been fed back to Abbott).



### **Revised Deadline for November Claim Submissions**

This is to advise that similar to previous years, PSD will be making earlier payments in December, as a result NHS Grampian are required to submit payment figures at an earlier date. As a result of this PCCT require claim submissions to be received no later than **12pm on Friday 6**<sup>th</sup> **December**. Claims received after this time will be processed the following month.

# **Smoking Cessation Update**

### Varenicline

Please be reminded that Varenicline has been reintroduced but is not yet available to use as part of the smoking cessation programme in Scotland.

Realistically it will be into next year that we receive the updated PGD, which is currently being updated at a national level and staff will require some training on it once finalised. We may also need to wait until enough stocks become available.

In the meantime, we advise that you continue to use the NRT products available as part of the 12 week programme. We'll keep you posted as things evolve.
