Grampian Travel Health Service Launch

The new Grampian Travel Health Service is launching soon. Information about how to use the new service is available on the <u>Travel Vaccination | Vax Grampian</u> website now for those who need assessments and vaccinations from NHS Grampian Travel Health Service.

Risk assessment forms will be available here <u>Travel Vaccination | Vax Grampian</u> from Wednesday 15th January 2025 and the full service will launches on Monday 3rd February 2025.

Patients who are part way through a vaccination course (eg. Hepatitis A) can email to arrange to receive their second dose: gram.travelhealth@nhs.scot.

Please note general practice do not offer a travel health service.

Private GLP1 Prescribing

Please find the attached letter for community pharmacies regarding private GLP1 Prescribing, which has also been sent via email from Primary Care Contracts.

Flu Referral Form: Drugs and Alcohol Service for Distribution

Please find attached the Drugs & Alcohol Flu Referral form, the purpose of this form will allow keyworkers to identify the name of the individual and then sign off to confirm they can walk into any Vaccination Centre to be vaccinated. Staff will be notified that upon receipt of this form, they will be aware that they are being referred due to drugs and alcohol - without the person having to state this when they arrive.

This provides eligibility for Flu, the vaccinator can then check their eligibility for COVID as required.

Smoking Cessation Update

Shared Care Button on PCR for Smoking Services

It has been brought to our attention that many pharmacies have been putting "YES" in the "shared care" box which comes up in the initial capture section of the PCR. This box should ONLY be marked YES if care is being shared with another service, for example Healthpoint or GP. Moving forward, please **INSERT** "NO" IN THE SHARED CARE BOX UNLESS CARE IS CURRENTLY BEING SHARED WITH ANOTHER SERVICE. This will be unlikely at the pharmacy point of contact.

As mentioned previously, Healthpoint will be picking up patients who have had 4 or more attempts within pharmacies in a year. They will provide EXTRA behavioural support and you need not do anything different. Please be reminded of the new patient information leaflet attached which should be provided digitally or in print to all new smoking sign-ups. Many thanks for your cooperation with this!
