### New Universal Claim Framework (UCF) Module for Pharmacy First Plus

On 1<sup>st</sup> February 2025, a new UCF module launched specifically for Pharmacy First Plus which will provide more accurate reporting on service activity. When a Pharmacy First Plus consultation has been undertaken, this module should be used instead of the standard Pharmacy First module.

### **Creon Supply Issues**

We continue to experience intermittent supplies of Creon, which is anticipated to continue into early 2026. Following a further NPSA in December there have been minor updates to the NHS Grampian PERT Shortage Management Information which is available via Grampian Guidance. Community pharmacy teams are asked to familiarise themselves with the content of PERT shortage guidance, in particular the requirement to restrict quantity of supplies as per Serious Shortage Protocols.

### **Patient Request for GLP-1 Prescribing**

Please find attached a patient information leaflet which is intended to support Primary Care conversations with patients requesting prescribing of GLP-1 medications for weight loss/obesity.

### **Updated Guidance for Online Pharmacy Services**

Superintendent Pharmacists are now jointly responsible with pharmacy owners for meeting the guidance and all members of the team are expected to follow the guidance at all times.
