Controlled Drugs Team Update

Supply of Oral Morphine Solution on CPUS

Following a review of medication supplied under the community pharmacy urgent supply arrangements (CPUS) the Controlled Drugs Team wish to remind community pharmacists of the following:

- All schedule 2 and 3 controlled drugs are excluded under this patient group direction (PGD), except midazolam oromucosal solution for the emergency treatment of status epilepticus.
- All morphine containing preparations are excluded under the CPUS PGD. Morphine 10mg/5ml oral solution is a schedule 5 controlled drug but must not be provided under this PGD and any supplies will not be reimbursed.
- Patients requiring drugs excluded under this PGD should be referred onto the GMED service if the supply is felt necessary.
- Community pharmacists should exercise their professional judgement and consider limiting the quantity supplied for a medication which has the potential for abuse.

Smoking Cessation Update

Smoking Cessation Service Data for Q2 July-Sept 2024

The graph above shows the most recent data for Quarter 2 July-Sept 2024 for all the community pharmacies in Grampian collectively, along with the previous 3 quarters for comparison. The data is always 6 months behind.

Unfortunately smoking sign-ups have dropped by over 100 patients and missed 4-week submissions have risen again. On a more positive note the percentage of 12-week quits went up by 1% to 21% but still falls short of the Scottish Pharmacy average of 22.9%.

Please raise awareness leading up to No Smoking Day on 12th March and review house-keeping to ensure that submissions are submitted on time.

From 1st April 2025, you will not be paid for submissions out with the allotted PCR timeframe.
