Advagraf to Dalliport Renal Transplant Patients

For information, the Specialist Renal Service are about to review and switch a small number of renal transplant patients from Advagraf® to Dailiport® (tacrolimus) oral therapy.

This change in brand will be managed by the Specialist service. They will write to the patients/relevant GP practices and community pharmacies to advise of any changes to treatment on an individual patient basis. The Specialist service will ensure any required blood tests are undertaken and advise of any dose adjustments as necessary.

Practices should continue to prescribe Advagraf®, as currently, unless contacted to advise of this change on an individual patient basis. **This change is for renal transplant patients only.**

Patient Group Direction for the Supply of Vareniciline Tablets

Please find attached the Patient Group Direction for the Supply of Varenicline tablets to patients aged 18 years and over by approved community pharmacists working within NHS Grampian, Highland, Orkney, Shetland, Tayside and Western Isles, Version 1.

Monthly Claim Workbook – Buvidal Claims

Buvidal Administration is currently an *invitation only* SLA. Please note a pharmacy should only be entering data into the Buvidal column if they have *administered* injectable Buvidal to a patient. A claim should not be entered for dispensing Buvidal alone. There have been a number of claims submitted for Buvidal in error from pharmacies that are not signed up to the SLA for Buvidal administration and are therefore not administering. Primary care contracts team will be in contact to arrange reclaim of moneys for any claims made in error.

Datix Incident – Lessons Learned

Datix is used to report incidents, risks and near misses across NHS Grampian, which enable us to learn from these experiences and improve patient safety. We have received a number of reports involving compliance aids over the past few months, so thought there is some good learning points for you all to reflect on from these investigations.

Situation: Patient receives a weekly compliance aid, one of the medications in their box is paracetamol 500mg tablets, two to be taken four times per day. A prescription was provided to the patient for co-codamol 8/500mg tablets (100) for an acute presentation of pain, dosage two tablets four times per day. Two weeks later, another prescription is provided to the patient for co-codamol 15/500mg tablets (100), dosage two

tablets four times per day. Both of these acute prescriptions were dispensed at community pharmacy, and compliance aid continued to be supplied with paracetamol inside it.

Investigation: Community pharmacy supplied both acute prescriptions for co-codamol, not noticing this patient was a compliance aid patient and already receiving paracetamol at the maximum licensed dose. The prescriber, on both occasions, did not notice that this patient was a compliance aid patient and that they would already be supplied paracetamol. This led to an unintentional possible overdose for this patient, for a prolonged period of time. This patient had a fall, and was subsequently admitted to hospital- it was during the admission process that this error was discovered.

Learning: Both the community pharmacy and the GP practice have revised their processes for patients who receive a weekly compliance aid. The community pharmacy has updated their SOP, to ensure their PMR highlights when labelling, that a patient receives a weekly compliance aid- this will ensure that this is flagged to the pharmacist for clinical checking before dispensing/supply to patient. Any changes to the patient's medication is also now recorded on a separate sheet for that patient.

Please use this example to think about your own pharmacy- do you have a robust SOP in place for when dispensing prescriptions for patients who receive a compliance aid? Do you have a process in place that ensures you receive notification from GP practices when there is a change to a compliance aid patient's prescription?

Naloxone in Community Pharmacy

Please find attached a reminder of the letter shared on 24th April, around the supply of naloxone via community pharmacies. This document has been created by the SUS pharmacist team and is supported by the pharmaceutical care services team. Please ensure all pharmacy teams read this, and the following actions for your teams:

Actions for Pharmacy Teams

- Be aware of the information contained in this document.
- Ensure the Pharmacy has appropriate naloxone stock to provide the service(s).
- Ensure naloxone stock is in-date, re-order if not and claim as per the service specification(s).
- Note some Naloxone products are only supplied by certain wholesalers.
- Be aware of RADAR alerts and local alerts and act where needed.
- Ensure staff are familiar with the signs of overdose, and of the increased incidence currently.
- All members of the pharmacy team should be aware of both services (emergency supply and "take home" supply) and have undertaken the appropriate training.
- Be able to signpost to local treatment services.
