## Nystatin - SPS Update

Please find the below summary and update from SPS, in relation to enquiries of obtaining nystatin:

- Nystatin oral suspension is available, but a change from branded (Nystan) to non-branded generic is causing confusion in the supply chain, resulting in stock not reaching pharmacies.
- Pharmacies should ensure their system orders generic nystatin suspension, not Nystan (the brand).
- Prescribers should prescribe as generic nystatin suspension, not Nystan, as pharmacies will be unable to dispense prescriptions for branded Nystan.

## Reminder: Buprenorphine Prescribing Switch

NHS Grampian are enacting a prescribing switch for patients receiving oral Buprenorphine products for opioid dependency. Attached is a community pharmacy leaflet which explains the rationale behind this switch and the actions for community pharmacies. There is also a patient leaflet attached which is for reference and can be given to patients for further information. Please ensure all community pharmacy staff members read the community pharmacy leaflet and action all relevant points.

Communication should be made to community pharmacies prior to Buprenorphine product changing by the patients prescriber/keyworker to allow time for pharmacy to order in the new Buprenorphine product, or prescriptions should be delivered to pharmacies in advance to allow new product to be ordered in time for prescription starting. ## Reminder: Paxlovid Endorsing Guidance – 1<sup>st</sup> May 2025

The attached amended NHS circular PCA(P)(2025)08 informs NHS Boards and community pharmacy contractors of new arrangements in place for the procurement and reimbursement of Paxlovid® (nirmatrelvir and ritonavir).

## Udney Station Branch Closure

Last year, Scotstown Medical Group informed the health board and HSCPs in City and Shire of its decision to close the branch surgery in Udney Station. This difficult decision was made after discussions since pre-covid and was made to safeguard the long-term sustainability of the practice, ensuring it can continue to meet the growing demand for general medical services.

All patients living in the community of Udney Station will remain registered with Scotstown Medical Group, and therefore full service is maintained. A list of all nearby available pharmacies and delivery options has also been published on the Practice Facebook and website.

Patients have the right to register freely with any practice if their home postcode is within the practice's boundary area. However, we are not currently undertaking any movement of patients to ensure a managed approach to any transfers which has been in place since last year to support Shire practices. Patients' right to move will be reinstated from 9th September 2025. Patients of Scotstown can continue to be registered and the practice have offered New Dyce as an additional venue for attending appointments should this be preferable.

### Reminder: Email and Telephone Monitoring

Please ensure that you regularly check your NHS email account and remain attentive to incoming telephone calls throughout the day. Checking emails should be regarded as a critical task and carried out multiple times during the day. Unread messages may contain urgent information related to patient care or medication. We understand how busy you all are, and appreciate the challenges you have.

Regarding telephone calls, we understand that they can be disruptive and that pharmacy staff are often managing multiple responsibilities simultaneously. To help manage workload more effectively, have you considered implementing a rota system? In many pharmacies, designated team members are assigned to handle telephone calls during specific time windows. This approach can help distribute responsibilities more evenly and reduce pressure on individual staff members.

### Vaccination Management Tool (VMT)

Please note that you can still use VMT for recording vaccines that are eligible for NHS vaccination, even when supplying them privately. VMT accounts which are not accessed in over 3 months are deactivated and you will require to reapply for access on the following link: <https://forms.office.com/e/MpfTAaq1WH>.

This process is to ensure access is granted to those who require it and covers all users within NHS Grampian.

### Smoking Cessation Update

#### Varenicline Update – IMPORTANT

Few things to highlight:

- **PGD** – NHS Grampian have released the Varenicline PGD, please find it attached, sign and send back to us as soon as possible. We will be collating a list of all participating pharmacies. Please remember that, even if you are an independent prescriber, you will need to sign the PGD if you decide to supply to patients using it.
- **Training** – All staff undertaking the smoking cessation service MUST complete the mandatory course before commencing the service. If you were already familiar with the old Champix, then you can skip to the assessment. <https://learn.nes.nhs.scot/1475/pharmacy-cpd-resources/pharmacy-services-essential-learning/community-pharmacy/nhs-scotland-smoking-cessation-service>.
- **CO monitoring** – The PGD states that CO monitoring “should” be used, it is not mandatory. Grampian has not re-introduced CO monitoring into pharmacies since COVID. The monitors have a shelf life of around 4 years and therefore all monitors in Grampian community pharmacies would need to be replaced which comes at a very high cost. However, this is currently under review and we will keep you updated with the decision.

- **Smoking Cessation Service Specification and PCR** – these are both areas under review for improvement and will be finalised by this time next year.
- **Vaping** – This is an area under review at CPS and it is hoped that pharmacies will be able to support vapers to quit vaping in due course. For now, please keep referring to the tobacco and vaping pathways.

## Public Health Update

### Could Your Pharmacy Achieve the GOLD Award?

The GOLD awards are a Public Health initiative where pharmacies are rewarded for delivering a range of more advanced public health services as well as delivering a high standard of core services.

The criteria may change yearly depending on Government objectives and initiatives and you may be asked to take part in small pilot projects.

If you feel your pharmacy can meet all the criteria areas (PDF attached) and would like to work towards this award, please submit an email to [gram@pharmaceuticalcareservices.nhs.scot](mailto:gram@pharmaceuticalcareservices.nhs.scot) before **Friday 30<sup>th</sup> May** stating:

- Your pharmacy name and branch
- Your lead pharmacist prescriber's name
- Who would be your nominated Public Health Champion(s)
- A short blurb telling us why extra public health services would be good within your community

Please note that we only have 6 spaces this year. Pharmacies will be prioritised on their SIMD area, their smoking cessation data and their logistical space to have a health promotion area (this could involve window displays).

A one-off payment of £1100 will be provided to allow time for staff training and to purchase any display materials. This will consist of an upfront payment of £600 and a final payment of £500 on completion of the criteria and submission of feedback forms.

Payment for yearly revalidation is under review. Successful pharmacies will be alerted by Monday 16<sup>th</sup> June and initial visits will commence June/July 2025.

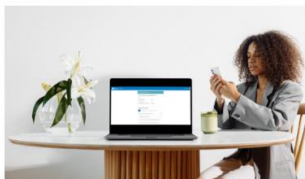
