Antivirals for Patients at High Risk of Complication from Covid-19

Since the end of May 2025 the National supplies of Paxlovid and Molnupiravir are no longer available. Therefore these now need to be purchased via the normal wholesale route under the National Arrangements for the Supply of Medicines (all stock pharmacies held until the end of May 2025 will now be expired and must be disposed of accordingly). As the assessments are undertaken remotely, the prescriptions we use for the service locally are issued via CoPPr.

Treatment with the antivirals needs to be initiated within the first five days of onset symptoms, meaning there is a time sensitivity for the patient in terms of presenting, being assessed and starting treatment.

NHS Grampian has decided to arrange for two pharmacies, Boots Garthdee and Boots Springfield, Elgin to hold two packs of each medication in stock to supplement the usual supply routes. Whilst a CoPPr prescription could come to any pharmacy requesting a supply be provided to a patient, we recognise that supplies will be delayed at weekends or that a patient may need to start their treatment immediately to be within the optimum time window. The availability of stock at the two pharmacies means there should be a route of almost guaranteed access for patients either via their normal community pharmacy if they can wait for a supply to be ordered or from one of the two Boots branches if they cannot (please disregard the information in attached letter regarding antivirals around Paxlovid- stock has now been replenished at Alliance- see below for more details).

We have chosen these two pharmacies based on location and opening hours. The level of stock and whether we need to expand the locations further. This will be kept under review based on whether circulating Covid levels and assessment rates change in the future, but we believe this arrangement is a suitable backup for normal access routes currently.

Reminder: Out of Stock Medicines Procedure

Where there is a genuine medicine shortage and you cannot fulfil the requested prescription, the following actions should be taken:

- a) Check all available wholesalers
- b) Check supplies with all other pharmacies in your network
- c) Review the unavailable medication information / MSAN on SPS: <u>Medicines supply SPS Specialist</u> Pharmacy Service The first stop for professional medicines advice.
- d) Prepare a list of available alternative(s) to share with the patient's practice (please share this with colleagues if e.g. pharmacy dispenser phoning practice to report the shortage)
- e) Contact the practice and provide this alternative information. If there is uncertainty about the indication for treatment and the patient isn't available to confirm this, please discuss with the prescribing clinician.

If you receive a repeat or serial prescription for a known unavailable product, please do not wait until the patient attends for collection before you action this.

Finally, practice teams are generally in touch with each other and with multiple pharmacies; they also have the ability to look at shortage lists and contact wholesalers. Misinforming practices that a supply is not available when in fact it is available but not at the price below the tariff is likely to lead to a complaint about failure to deliver contractual obligations. Likewise, patients are increasingly vocal about pharmacies failing to provide certain medicines when they are freely available from other pharmacies.

Opening New PCR Files

You may remember that there were some updates to the PCR system last year. One of these changes was that you could open multiple files for the same patient to allow easy transfer between pharmacies. Unfortunately the National ISD system is not compatible with these changes and therefore we ask you all to defer back to the previous system. Advice is not to open a new PCR file for your patient until the following week (a Thursday must pass for National upload). Opening 2 files may result in missed payment.
